WHEREAS, the Commission has submitted to the people of Oregon City for their approval or rejection a charter amendment contained in a resolution filed with the City Recorder on March 10, 1961, to be voted upon at a special city election to be held on April 7, 1961, and

WHEREAS, on March 13, 1961, the City Recorder requested the City Attorney to prepare a ballot title for said charter amendment contained in said resolution proposed by the Commission, and

WHEREAS the City Attorney on March 13, 1961, pursuant to the Charter of Oregon City, has provided, returned and filed with the City Recorder ballot title for said measure as follows:

Charter amendment amending the Charter by adding Chapter VIII-E, authorizing construction of portion of trunk sewers and pumping station to serve Molalla Avenue area, providing secondary treatment for present sewage plant, correcting existing sewers in Oregon City and purchasing present sewer lines of School District No. 62-C in Oregon City, including rights of way, property, easements, purchasing, constructing, installing units, pipe, equipment, structures, therefore, empowering the Commission of Oregon City to issue and sell negotiable bonds to the amount of \$350,000.00, therefore, to be repaid within twenty years and authorizing a levy.

AND WHEREAS no objections to said ballot title have been filed by any persons

NOW THEREFORE BE IT RESOLVED, by the Commission of Oregon City that said ballot title above, be and the same is hereby approved.
