

Oregon City, Oregon, June 24, 1948

SPECIAL MEETING

The City Commission met in special session on the above date in the office of the City Manager at the City Hall at 8:00 p.m.

Roll call showed the following present:

George Woodward, Commissioner  
Alden Miller, City Attorney

The purpose of the meeting was the public hearing of the budget and the consideration of Ordinance #1352 making the annual tax levy for Oregon City.

A group of representative property owners met with the Commission and discussed the budget item for item. There being no dissension the property owners unanimously voted at 9:07 daylight saving time, i.e. 8:07 Pacific Standard time, that the budget should be adopted as published.

Ordinance #1352 was read the first time and ordered published.

ORDINANCE NO. 1352

An Ordinance making a tax levy for Oregon City for the last six months of the year 1948 and the first six months of the year 1949 ending June 30, 1948 and deslaring an emergency.

OREGON CITY DOES ORDAIN AS FOLLOWS:

Section 1. That there be and is hereby levied upon and against all property within the corporate limits of Oregon City, Oregon which is assessed and taxable for the fiscal year 1948-1949 for State and County purposes and for the purpose hereinafter set out, which sums of money are hereby levied pursuant to the general laws of the State of Oregon, and which authority is invested in Oregon City by the Charter of Oregon City.

Section 2. The sum of \$12,000 to provide a fund for the operation and maintenance of a Recreation Department.

Section 3. The sum of \$13,240 to provide a fund for maintenance of the Oregon City free library.

Section 4. The sum of \$24,000 to provide a fund for the construction of a sewage disposal works.

Section 5. The sum of \$6.000 for a fund to provide additional street lighting in Orëgon City.

Section 6. The sum of \$49,160 to provide a fund for the general municipal expense of Oregon City.

WHEREAS, it is necessary that Oregon City, Oregon raise the said sums of money for defraying the expense of the government for the fiscal year 1948-1949 ending June 30, 1949 and it is necessary to protect the peace, health and safety of Oregon City, Oregon by raising the said sums, an emergency is hereby declared and this ordinance shall go into effect immediately upon its final passage and approval by the Mayor.

Read first time and ordered published at a special meeting of the City Commission held on the 24th day of June, 1948, and to come up for second reading and final passage at a regular meeting of the City Commission to be held on the 7th day of July, 1948 at the hour of 2:00 p.m. day light saving time, i.e. 1:00 P.M. Pacific Standard Time.

The following resolution was introduced and on motion adopted.

### RESOLUTION

WHEREAS Oregon City has adopted Ordinance No. 1349 which provides by Section 13 thereof that the City Manager, subject to the approval of the City Commission by resolution, may designate no parking areas and traffic lanes in Oregon City, Oregon,

NOW THEREFORE BE IT RESOLVED That the City Manager, be and he is hereby authorized and directed as follows:

To prohibit parking on the Northerly side of the cut-off at 11th Street and Moss Street between the Pacific Highway 99E and Main Street except that portion where parking meters have been installed.

To designate Railroad Avenue from 7th Street to 9th Street as a one way street with the traffic to travel one way -- in a Northerly direction.
