SPECIAL MEETING

The City Commission met in special session on the above date in the office of the City Manager at the City Hall at 8:00 o'clock p.m.

Roll call showed the following present:

The purpose of the meeting was the public hearing on the budget and consideration of Ordinance No. 1362 making the annual tax levy for Oregon City.

As only two property owners appeared, the budget, as published, was unanimously adopted.

Ordinance No. 1362 was read the first time and ordered published.

ORDINANCE NO. 1362

AN ORDINANCE making a tax levy for Oregon City for the last six months of the year 1949 and the first six months of the year 1950 ending June 30, 1950 and declaring an emergency.

OREGON CITY DOES ORDAIN AS FOLLOWS:

Section 1. That there be and is hereby levied upon and against all property within the corporate limits of Oregon City, Oregon which is assessed and taxable for the fiscal year 1949-1950 for State and County purposes and for the purpose hereinafter set out, which sums of money are hereby levied pursuant to the general laws of the State of Oregon, and which authority is invested in Oregon City by the Charter of Oregon City.

Section 2. The sum of \$12,000 to provide a fund for the operation and maintenance of a Recreation Department.

Section 3. The sum of \$14,040 to provide a fund for the maintenance of the Oregon City free library.

Section 4. The sum of \$24,000 to provide a fund for the construction of a sewage disposal works.

Section 5. The sum of \$6,000 for a fund to provide additional street lighting in Oregon City.

Section 6. The sum of \$28,000 to provide a fund for the purchase and maintenance of equipment for the fire department.

Section 7. The sum of \$52,104 to provide a fund for the general municipal expense of Oregon City.

WHEREAS, it is necessary that Oregon City, Oregon raise the said sums of money for defraying the expense of the government for the fiscal year 1949-1950 ending June 30, 1950 and it is necessary to protect the peace, health and safety of Oregon City, Oregon by raising the said sums, an emergency is hereby declared and this ordinance shall go into effect immediately upon its final passage and approval by the Mayor.

Read first time and ordered published at a special meeting of the City Commission held on the 20th day of June, 1949 and to come up for second reading and final passage at a regular meeting of the City Commission to be held on the 6th day of July, 1949 at the hour of 8:00 p.m. daylight saving time, i. e. 7:00 p.m. Pacific Standard Time.
