The Clairmont Water District will build a twelve (12) inch cast iron water line from the connection as approved in the vicinity of the Oregon City Reservoir No. 2 to a point near the intersection of the Molalla and Beavercreek Roads.

The City to purchase this pipe line from the District within five (5) year period. The District would like City to provide the necessary easements.

Connection to existing line or lines in Oregon City as approved to be at the expense of Clairmont Water District.

The Commission agreed that a letter be prepared and sent to the Clairmont Water District stating the conditions and terms for the construction of a pipe line to handle water from a point near the Oregon City Reservoir No. 2 to a point near the intersection of Beavercreek and Molalla Roads.
