The Commission was presented with a proposed agreement between the City and the State of Oregon through its State Highway Department on the Sportcraft Landing development. It was moved by Conrad, seconded by Danielson, to authorize the Mayor and the City Recorder to sign the agreement between the City of Oregon City and the State Highway Department.

Ayes: McElroy, Conrad, Danielson. Nays: None.


It was moved by Conrad, seconded by Danielson, to urge citizens to oppose Ballot Measure No. 7 regarding the constitutional amendment changing the proposed tax limitation to 1½%.

The Commission was informed that the Canemah walkway has been completed but that the City has not received formal notice of completion. The Commission requested the Manager to explore the possibility of street lights in this area for the Canemah walkway.

REGULAR MEETING

The regular meeting of the City Commission was held on the above date in the Commission Chambers at City Hall at 8:00 p.m.

Roll call showed the following present:

The minutes of the previous meeting were approved as read.

Mr. R. M. Ingersoll of Oregon City Realty was present to discuss the possibility of annexing and rezoning property outside the city limits near Warner-Milne Road and Linn Avenue. Mr. Ingersoll stated that he was representing Globe-Union, Inc. Mr. Joe Griffey, Manager of Globe-Union, was also present. Mr. Ingersoll stated that they would like to have this property zoned as industrial property. The property which includes $6\frac{1}{2}$ acres is owned by Elmer Wagner. This was continued for further study.

A report was read from Jack B. Donahue, City Engineer, and Duane O'Brien, Fire Chief, on proposed condemnation against the property owned by Elmer F. Wagner, Rt. 1, Box 378, Oregon City, known as the Lone Maple Tree Store. Mr. Wagner was present and stated that he is renting the building to Mr. Lee Richmond who is operating a grocery store and service station. It was moved by Conrad, seconded by Danielson, to continue this to the November 14 meeting of the Commission.

It was moved by Danielson, seconded by Conrad, to continue condemnation proceedings against the Anna Harkey property, 124 Linn Avenue, to the December 4 meeting of the Commission.

It was moved by Conrad, seconded by Danielson, to continue the proposed condemnation proceedings against the Woodward Building at 7th and Center Streets, to the January 7, 1969 meeting of the Commission.

It was moved by Danielson, seconded by Conrad, to discontinue condemnation proceedings against the Willis Hinkle property at 975 Woodlawn Avenue.

Discussion was held on a petition to vacate a road in the Hartke Plat. It was moved by Danielson, seconded by Conrad, to continue this to the November 14 meeting to allow the developer, Walter Parrott, to have a correct description of the property.

Proposed Ordinance No. 1667, an Ordinance amending Title XI, Chapter 2, Section 2 of the 1963 City Code, ZONING DISTRICTS: MAPS, of Oregon City, by changing certain districts; was read the second time and on motion by Conrad, seconded by Danielson, placed on its final passage and, it appearing from the certificate of Judy Conner, Principal Clerk of the Enterprise-Courier, that the same has been properly published as required by Charter, the ordinance was passed.

Proposed Ordinance No. 1668, an Ordinance declaring the assessment for the cost of Sewer District No. 28 and declaring an emergency, was read the second time and,
