SPECIAL MEETING

The City Commission of Oregon City met in special session on the above date in the office of the City Manager in the Municipal Building at one o'clock p.m.

Roll call showed the following present: Pace, Caufield and Harding, commissioners; J. L. Franzen, City Manager.

The following ordinance No. 1220 was read the first time and ordered published:

ORDINANCE NO. 1220

An ordinance establishing the grade of Caufield street from the westerly side of Pleasant Avenue to the westerly side of Latourette street in Oregon City, Oregon.

OREGON CITY DOES ORDAIN AS FOLLOWS:

Sec. 1. The grade of Caufield street from the westerly side of Pleasant Avenue to the westerly side of Latourette street is hereby changed from the present existing grade to the following described grade to-wit:

Beginning at the south side of Caufield street and the west side of Pleasant Avenue at elevation 452.5, and on the north side of Caufield street at 451.5, thence westerly 50 feet to elevation of 456.0 on the south and 454.8 on the north side, thence 50 feet to elevation of 458.2 on the south and 457.2 on the north, thence 100 feet to the east side of Dimick street at elevation of 461.4 on the south and 461.4 on the north, thence across Dimick street to elevation 464.4 on the south and 464.4 on the north, thence west 65 feet to elevation 469.2 on the south and 468.6 on the north, thence on a vertical curve 100 feet long to elevation 469.8 on the south and 468.6 on the north, thence 35 feet to east side of Latourette street to elevation 467.4 on the south and 466.4 on the north, thence across Latourette street to 465.6 on the south and 464.4 on the north.

. Whereas the condition of said street is dangerous to the peace, health and safety of the people of Oregon City, and it is necessary for the immediate preservation of the peace, health and safety of the people of Oregon City and the public that an emergency is hereby declared to exist, and this ordinance shall take effect and be in force immediately upon its approval by the mayor.

Read first time at a special meeting of the city commission held on the 27th day of October, 1930 and to come up for second reading and final passage at a regular meeting to be held on the 5th day of November, 1930 at 1:00 p.m.

Ordinance No. 1221 was read the first time and ordered published.

ORDINANCE NO. 1221

An ordinance for making an improvement of Caufield street in Pleasant Hill Addition from the westerly side of Pleasant Avenue to the westerly side of Latourette street in Oregon City, Oregon.

OREGON CITY DOES ORDAIN AS FOLLOWS:

Sec. 1. That the proposed improvement of Caufield street from the westerly side of Pleasant Avenue to the westerly side of Latourette street in Oregon City, Oregon; shall be made according to Improvement No. 1, according to the plans and specifications on file in the office of the city recorder of Oregon City, Oregon, and approved by resolution adopted on the 1st day of October, 1930, by the city commission of Oregon City, which said plans and specifications are hereby referred to and made a part of this ordinance. The improvement shall be constructed as follows:

The street shall be brought to subgrade its full width of 40 feet from the westerly side of Pleasant Avenue to the westerly side of Latourette street. On the road bed shall be placed crushed rock 6 inches thick, 9 feet on each side of the center line of said street. The street shall be properly provided with drains and gutters necessary to provide drainage for the street. All of the improvement shall be made according to plans and specifications which are hereby referred to and made a part of this ordinance and were filed on the 1st day of October, 1930, in the office of the city recorder, which plans and specifications and estimates are hereby approved.

Sec. 2. The improvement shall be classed as macadam and shall be maintained by Oregon City for the full period of ten years from the date of the acceptance thereof by the city commission.

Sec. 3. The mayor and city recorder are hereby authorized and instructed to enter into contract with Johnson & Scott for the improvement hereinbefore specified, the contract to contain a stipulation to the effect that where the cost of the improvement under the provisions of the contract shall exceed one half of the value of the property assessed for the cost of the improvement, that the said excess shall be paid out of the general fund of Oregon City, Oregon, and as to the balance the contractor shall look for payment to the sum assessed upon the property liable to pay for said improvement, and collected and paid into the city treasury of Oregon City for such purpose, and they shall not hold Oregon City by any legal process or otherwise to pay said sum out of any other fund.

Whereas, the condition of said street is such that it is necessary to make the improvement as soon as possible to preserve the peace, health and safety of the inhabitants of Oregon City, an emergency is hereby declared to exist, and this ordinance shall take effect and be in force immediately upon its approval by the mayor.

Read first time and ordered published at a special meeting of the city commission held on the 27th day of October, 1930, and to come up for second reading and final passage at a regular meeting of the city commission to be held on the 5th day of November, 1930, at the hour of 1:00 p.m.
