## Special Meeting

The City Commission of Oregon City met in special session on the above date in the office of the City Manager in the Municipal Building at one o'clock p.m.

Roll call showed the following present: C. H. Caufield and L. O. Harding, commissioners; J. L. Franzen, City Manager.

The purpose of this meeting was to consider the first reading of Ordinance No. 1213. The ordinance was read the first time and on motion ordered published.

#### ORDINANCE NO. 1213

An ordinance declaring the assessment for the improvement of the following named streets and sewer:

Railroad Avenue, from the north side of Fifth street to the south side of Seventh street,

Fourth street from the east side of J. Q. Adams street to the concrete pavement on Linn Avenue,

Lincoln street, from the south side of Fourteenth street to the south side of Twelfth street,

Railroad Avenue, from the north side of Eighth street to the south side of Ninth street,

Sewer in District No. 22, Canemah.

OREGON CITY DOES ORDAIN AS FOLLOWS:

Section 1. The assessment for the improvement of the following streets and sewer in Oregon City, Oregon, has been levied and declared according to Assessment Rolls, and the total cost thereof as hereinafter stated.

Railroad Avenue, from the north side of Fifth street to the south side of Seventh street.

Assessment Roll No. 1929 "A". Total Cost \$5,486.37.

Fourth street, from the east side of J. Q. Adams street to the concrete pavement on Linn Avenue.

Assessment Roll No. 1929 "D". Total Cost \$1,633.98.

Lincoln street, from the south side of Fourteenth street to the south side of Twlefth street.

Assessment Roll No. 1929 "C". Total Cost \$1,936.02.

Railroad Avenue, from the north side of Eighth street to the south side of Ninth street.

Assessment Roll No. 1929 "B". Total Cost \$1,447.34.

Sewer in District No. 22, Canemah

Assessment Roll No. 1929 "E". Total Cost \$10.357.64.

Section 2. Whereas, the condition of said streets was dangerous to the health and safety of the people of Oregon City, and the public, and it is necessary for the immediate preservation of the health and safety of the people of Oregon City that this ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor.

Read first time and ordered published at a special meeting of the City Commission of Oregon City, Oregon, held on the 26th day of December, 1929, and to come up for second reading and final passage at a special meeting of the City Commission to be held on the 20th day of January, 1930, at the hour of one o'clock p.m.

Mrs. Augusta Powers presented a quit claim deed to the property described in deed book 129, page 411, stating that she would rather deed this property to the City, than to pay the assessments against the same. Upon investigation it was found that there was \$35.57 taxes due. On motion the deed for this property was accepted and the taxes ordered paid.

There being no further business, the meeting adjourned.
