W. Lenz, Manager of the Oregon City Branch of the United States National Bank.

ADJOURNED REGULAR MEETING

An adjourned regular meeting of the City Commission was held on the above date in the Commission Chambers at City Hall at 1:00 P.M.

The reading of the minutes was ordered held over to the next meeting of the Commission.

Mayor Faust explained that proposed Ordinance No. 1523 had been read and published so that all could study it before appearing for discussion.

After the discussion Mayor Faust thanked the businessmen for being present and invited anyone to remain for balance of meeting, stating that the Commission would make a decision on Ordinance No. 1523.

Proposed Ordinance No. 1522, an ordinance providing for procedure without election to annex certain contiguous territory to Oregon City, Clackamas County, Oregon, fixing a day for public hearing before the Commission of Oregon City on the question of such annexation, directing publication of notice of such hearing and declaring an emergency, was read the second time and on motion by Bowman, seconded by McElroy, placed on its final passage and it appearing from the certificate of Dolores Harlan, Principal Clerk of the Enterprise-Courier, that the same has been properly published as required by Charter, the ordinance was passed.

On roll call: Faust, Aye; Bowman, Aye; McElroy, Aye.

The Manager presented an engineering contract with Stevens & Thompson, as required by State Sanitary Authority to be submitted with revised USPHS application for expansion of sewage treatment plant. It was moved by McElroy, seconded by Bowman, that the contract for engineering services be accepted and that the Mayor and the City Recorder be authorized to sign the contract.

On roll call: Faust, Aye; Bowman, Aye; McElroy, Aye.

The Manager presented a new application for federal funds for sewage treatment works. It was moved by McElroy, seconded by Bowman, that the Mayor be authorized to sign new application for federal funds.

Discussion was held regarding a continuation of the parking meter removal. It was moved by Bowman, seconded by McElroy, that the following resolution be passed:

RESOLUTION

Whereas, Oregon City has adopted Ordinance No. 1517 (amending sections 1 and 2 of Ordinance No. 1326), which provides by Section 1 thereof, that the City Commission by resolution may install, continue, remove or render inoperative parking meters on the public streets and public property in Oregon City, and by Section 2 may designate parking time, and

Whereas, by Resolution adopted October 23, 1962, the City Commission of Oregon City directed as follows:

All parking meter heads in Oregon City shall be removed effective Thursday, November 1, 1962, at 8:00 A.M. until Tuesday, January 1, 1963, at 8:00 A.M., except the 12 minute meter heads colored red in the down-town area between the westerly side of Railroad Avenue and the Willamette River.

Parking time in the present marked meter zone spaces, except the 12-minute parking meter zone spaces, shall be two hours and four hours as designated by signs in each block to be installed by the City Manager as hereinafter ordered.

and further directed the City Manager to install appropriate parking limit signs, which has been done in accordance with the above Resolution, and

Whereas, after careful study it has been determined to continue the parking time limits as set forth in the Resolution above for a further period.

Now therefore be it resolved that the Resolution of October 23, 1962, as to the removal of the meter heads, and the parking limit time be continued from January 1, 1963 at 8:00 A.M. until further Resolution of the City Commission, and the present regulations as set forth in said Resolution of October 23, 1962, shall continue in full force and effect until changed by resolution.

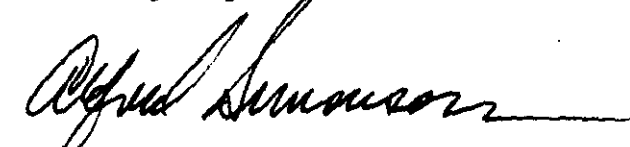
