This was the time for citizens to present items for consideration by the Commission on future agendas.

Ms. Diana Palmer, 645 SW Maple Crest Dr., Portland, requested to be placed on the next agenda for discussion of an ordinance to help enforce the new Charter change on animal euthanasia. The Commission asked that this item be placed on the agenda for December 10, 1981 meeting.

Mr. John Hardin, 816 S. McLoughlin, Canemah Neighborhood, requested study on problem at highway and Pacquet Street. The Mayor suggested that Mr. Hardin present written material to the City Engineer. The Commission asked that this item be placed on the agenda for December 10, 1981, meeting.

Mayor Andersen asked that Commissioner Thom report on his recent trip to Scotland. Commissioner Thom reported visiting a resource recovery plant outside of greater London. He stated the plant has been in operation since 1972, disposing of approximately 400,000 ton of garbage each year. He felt this was comparable to Oregon City's proposed plant. He commented on nice architectural design, large parking lots, and generation of electricity by mass incineration process. He noted they had no problems with either emission or odor complaints.

Mayor Andersen read a letter from Governor's Honorary United Nations Day Chairman, conveying thanks to all concerned in Oregon City. Mayor Andersen, again thanked Commissioner Johnson for his time and effort in this event.

Proposed Ordinance No. 1988, an ordinance amending Title XI, Zoning Chapter 4, supplemental zoning regulations and exceptions, section 1, accessory building and uses, subsection (g), swimming pools, of the 1963 City Code, was read the second time and on motion of Cartales, seconded by Thom, placed on its final passage and, it appearing from the certificate by Debi York, Principal Clerk of the Enterprise-Courier, that the same has been properly published as required by

Charter, the Ordinance was passed.

Mr. Quentin Rippey, stated that he has a 10-year lease and option to buy on the old Clairmont building and is not ready to annex at this time.

Mr. Larry Bennett, 19731 S Central Pt. Rd., spoke on behalf of his father, regarding property at 1613 Beavercreek Rd., adjacent to Clairmont building. He did not oppose Schwab annexation but did oppose any additional property being annexed.

Moved by Thom, seconded by Cartales that the annexation request of Tax Lot 600, proposed by Les Schwab be approved. He explained reason not requesting other property to be annexed at this time is because of dire economic circumstances that people are facing.

WHEREAS, the part of the territory that lies in the Clairmont Water District, the City Commission intends, in the event the annexation is consummated, to withdraw from that district by authority of ORS 222.520;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF OREGON CITY, a municipal corporation of the State of Oregon, at a regular session held on the 2nd day

The Commission was presented Manager's Report No. 81-15 regarding Tri-Met fare information, which had been requested by Commissioner Johnson. Mayor Andersen reported that Tri-Met has adopted new fares. Commissioner Johnson stated his concern that Fairless Square in Portland is being subsidized by the new tax structure. He felt busses in non-rush hours could be used to provide short bus runs for no fare or a small fare within the City Limits. The Commission agreed that there would be no problem if Commissioner Johnson wished to look into this further.

The Commission was presented Manager's Report No. 81-18, regarding Oregon City's Comprehensive Plan. The Planning Director explained LCDC's action and request for continuance of the City's plan to allow more time to deal with and resolve certain issues. She stated she would have draft report from their staff within ten days and could then meet with County staff and METRO coordinator and Commission to determine what direction they wish to take. Following discussion, it was moved by Cartales, seconded by Thom, that the General Manager is hereby authorized and directed to accept the request for an extension of time from LCDC to review the City's Comprehensive Plan and implementing measures, and City staff is to negotiate a revised "Dual-Interest Area" agreement with the County which would be compatible with City Commission direction with regard to development within the Urban Growth Boundary.

Next on the agenda was discussion on appointment of a Cable Television Advisory Board. Commissioner Thom stated, since this involves Liberty Cable Television, he would abstain from voting on this issue and declare a potential conflict of interest. The Manager presented Report No. 81-16 on this matter. The Manager presented a booklet "The New Communicators" which will be provided to each Board member. In reviewing the proposed composition of the Board, Commissioner Cartales commented her hope that the citizens at large would be selected from occupations other than those already provided for on the Board. The Commission reviewed the composition of the Board: 1 each from School District No. 62, Clackamas Community College, Oregon City Area Seniors, Council of Churches and 3 Oregon City Residents:at-large.

It was moved by Cartales, seconded by Johnson, that a 7-member board be appointed by the Mayor with composition of the Board to be 1 each from School District No. 62, Clackamas Community College, Oregon City Area Seniors, Council of Churches, and 3 Oregon City residents at-large.

Johnson, Aye; Cartales, Aye; Andersen, Aye. Commissioner Thom abstaining.

The Commission recessed at 9:05 p.m. and reconvened at 9:15 p.m.

Next considered was Commission Report No. 81-20, police vehicle bids. The Manager explained that staff felt bids were high and looked for an alternative. He informed the Commission they found that State Police vehicle bids meet or exceed those bid by Alexander's Chrysler-Plymouth, Portland. It was his recommendation to reject the low bid submitted by Alexander's Chrysler-Plymouth and to go along with the State bid, since this would mean a total savings to the City of \$4,210.20 on the three vehicles.

It was moved by Thom, seconded by Cartales, that the low bid submitted by Alexander's Chrysler-Plymouth, 2340 N. E. Sandy, Portland, in the amount of \$8,994.37 per vehicle, as approved on November 12, 1981, be rejected; and that the City instead purchase three Dodge Diplomats, Model GL41, through State bid in the amount of \$7,590.97 per vehicle.

Commissioner Thom expressed pleasure that the Police Department had the opportunity to do this. He noted that Clackamas County has a full-time purchasing agent and some items are common to other governmental agencies and wished the City to check into this opportunity, mentioning in particular, gasoline and oil. Mayor Andersen commended the Manager and staff. The Manager informed the Mayor that the City will go for private bids to sell the old automobiles.

Commissioner Cartales noted that Commission has placed a ban on reimbursement until this matter is solved. Commissioner Johnson reported he has bills and will continue to go to DEQ meetings. Commissioner Thom had no objection to Commissioner Johnson's being reimbursed for League meeting but felt to incur additional expenses is to assume risk of not being paid.
