Next agenda item was policy on false alarms, Police Department. Mayor Andersen reported on a letter from Dick Olson, opposing the policy. Chief Martin requested that this matter be continued so that he might draft formal ordinance with the City Attorney. It was moved by Thom, seconded by Cartales, to continue this to the second meeting in July.

Bill Parrish, City Engineer, explained the request of Ken Mitchell for a storm and sanitary sewer easement through Mountain View Cemetery, and suggested an easement along the boundary of the cemetery. He presented a copy of the proposed easement and map. He stated that Mr. Mitchell has agreed, as a consideration for the granting of the easement, to construct the sanitary sewer in its entirety, construct the storm sewer from his building to the upper limit of the existing storm sewer on the older part of the cemetery, and to provide the materials (pipe) to replace a section of this existing line which has become partially plugged with roots and debris. Mr. Parrish recommended approval of the easement. It was moved by Cartales, seconded by Thom, to approve Agreement for Easement with Kenneth B. Mitchell and the City of Oregon City.

The Commission was presented a quotation from Therm Control, Inc. for corrections to City Hall heating and ventilating system. The Manager explained that City Commission Chambers is not a balanced system on its own and the control is located in the Accounting Department corridor. Installation of another unit will put control in the Commission room and can cut down on heat when room is not in use. He noted Therm Control is the firm which has been handling heating/ventilating system in new building, using Carrier units. The Commission continued this matter to later in the meeting.

The Commission discussed policy to follow on quotations. The Manager explained procedure on formal call for bids as compared to that on quotations. Commissioner Johnson stated his opinion that City should get three quotations, and anything over \$5,000 should call for bids. Commissioner Cartales saw no problem with obtaining quotations and stated that Commission should keep in mind that it is not always the lowest quotation that should be selected. Commissioner Thom felt this policy should not apply to emergency items.

Following discussion, it was moved by Johnson, seconded by Cartales, that the Commission go to formal bids on anything over \$20,000. Commissioner Cartales questioned City Attorney if that would limit City administration from going to bid under \$20,000. The Attorney stated this would not limit to that amount but that, if Commission is going to adopt policy, should consider ordinance change. He pointed out that when Manager is getting quotations, he is bringing to Commission for decision.

He mentioned certain franchises over the years on line running into Publishers, negotiated approximately ten years ago, and another franchise on what was siding in the area of 15th and Center Streets. He said he had discussed this with Southern Pacific representatives and they apparently are not using this. He mentioned another franchise for depot facility which is in conjunction with same area of 15th Street. He stated, if any particular area the Commissioners think is being used by railroad, it can be checked out. The Manager noted at northern end of Railroad Avenue they go into own right-of-way until they hit street right-of-way at Center Street. Commissioner Johnson referred to Southern Pacific bridge which needs repainting and very dangerous intersection on 17th Street. The Manager informed the Commission that the City Engineer has been working on this. Commissioner Johnson wished to see a depot in Oregon City. Mr. Parrish stated he had been working with PUC on getting crossing at 17th Street, and they want City to widen 17th Street to meet minimum needs. He noted he had heard nothing from PUC recently.

Mayor Andersen asked if a letter could be directed to State Highway regarding City's complaint of passageway through underpass and also the Willamette Falls area. The Manager will write letter for Mayor's signature.

It was moved by Thom, that Commissioner Johnson be appointed a committee of one to pursue the location of a depot in Oregon City and to report back at later date. Motion failed for lack of a second.

EMERGENCY MEETING

Mayor Andersen called an emergency meeting to order (as scheduled on Friday, June 12, 1981) at 11:00 a.m., to hold additional discussion on Boxing Commission.

Roll call showed the following present:

Mayor Don Andersen Commissioner Edward Allick Commissioner Ron Thom Alfred Simonson, General Manager Dave Fish, Admin. Assistant Ruby M. Lampkins, City Recorder

The Manager reported he had checked on the City's liability insurance and was informed there was no additional exposure involved any more than other boards or commissions of the City. He did express concern about insurance carried by promotors.

Mr. Mike Rosser stated they would carry one million dollars in liability insurance and additional policy on fighters. He noted they are covered by same insurance as Hillsboro and Portland. Commissioner Thom stated City of Oregon City should be named on policy.

Mr. Rosser introduced Jim Gillette, Executive Secretary, Eugene Boxing Commission. He explained operating procedures in Eugene. He felt Portland's rules, were excellent and they had been adopted by City of Eugene Boxing Commission and may be modified from time to time. He stressed need for good referees, and recommended, if beer is sold, the Commission require that fights start on time. He recommended no elimination bouts and a check on mis-matching. Mr. Gillette volunteered his services for first two fights.

Following discussion, it was moved by Thom, seconded by Allick, that the City Commission of Oregon City establish a Boxing and Wrestling Commission and that the Mayor appoint the members thereof and that the members of the Commission be allowed to promulgate whatever rules are necessary and whatever conditions need be fulfilled to promote and have professional boxing or wrestling tournaments within the City of Oregon City.

Mayor Andersen appointed Commissioners Thom and Allick and himself to serve with Dr. Jonathan Hoppert on "City's" Boxing and Wrestling Commission until such time as the Commission can go through process of advertising for interested persons to serve.

Mr. Rosser recommended that Jim Gillette, Eugene, serve as Executive Secretary.
