The minutes of the meeting of April 1st, 1914, were read and approved.

The petition for a sewer on Madison Street between Third and Second Street was accepted and the City Engineer was ordered to prepare plans and specifications for same.

The Committee on Streets and Public Property requested an extension of time, for the consideration of the contract with the Portland Railway, Light and Power Company for City Lighting, which was granted.

The remonstrance against the improvement of East Street in Falls View addition was filed.

The petition for the improvement of East Street. Falls View Addition from the Southerly sid of County Street was read and it was ordered that the City Engineer prepare the necessary specifications for establishment of grade.

The remonstrance of H. C. Stevens against the Peanut and Popcorn Stand at the corner of Sixth and Main Streets was on motion referred to the Committee on Streets and Public Property and the chief of Police with power to act.

The request of Mr.Roll for the construction of a sidewalk in Falls View Addition was referred to the committee on Streets

and Public Property and Councilman Andrews.

The bill of the Oregon Bridge and Construction Company for extras concrete foundation work on the Elevator reduced to \$237.32 was accepted and ordered paid, on roll call the vote being as follows:

The question of West Linn wishing equal representation on the joint water committee was considered and on motion it was ordered that the same be not granted,

The communication of Norris Brothers in regard to the six months interest on Funding and refunding bonds in the amount of \$70,000 was ordered paid by warrants drawn therefore and the Treasurer instructed to remit same, on roll call the vote being as follows:

Fire and Water and the City Attorney with instructions to investigate same and report at a later meeting and the Recorder was directed to make copies of same for each member of the Committee and the City Attorney.
