WHEREAS, pursuant to an order of the City Council of Oregon City, Clackamas County, Oregon, heretofore made, the City Engineer of said city has submitted his report and filed in the office of the City Recorder plans and specifications for an appropriate flard surface improvement of Fifth Street, Oregon City, Oregon, from the east side of Main Street, to a point 222 feet east of the east side of Main Street and from the West side of Main Street and from the West side of Main St. to the East side of Water St., and estimates of the work to be done thereon and the cost there-

WHEREAS, such plans, specifications and estimates are satisfactory to Oregon City, Oregon;

THEREFORE, said plans and specifications and estimates are hereby approved and adopted and be it

proved and adopted and be it RESOLVED: That it is the intention of Oregon City, Oregon, to make the said improvement being described as follows, to wit:

The street shall be brought to subgrade the full width thereof, between the curbs, and the sub-grade shall be prepared according to the plans and specifications heretofore referred to. On the sub-grade so prepared, shall be laid a one-course concrete pavement laid 7 inches thick and 40 feet wide, with 6 foot concrete sidewalks on each side and standard concrete curbs, the center shall have a crown and sub-base as shown on plans, consisting of cement, sand and gravel or crushed rock, in the proportion of one, two and three, according to the specifications on file with the City Recorder of Oregon Cty. When the street is completed it shall be at the established grade. The life of the improvement shall be ten years.

The City Recorder is hereby directed to cause this resolution to be published as by the charter required.

The City Recorder was instructed to notify the Highway Commission that at this time the City could not do anythig twoards the completion of the Toilets on the Bridge and requested that the Commission close them up until arrangements can be made to complete them,

An ordinance establishing the grade of Waldamette Street from KNXXXXX Molalla Ave, to the East Side of Warren Street,

And Roosevelt street from Molalla Ave, to the east sage of Eluria St, Were read first time and ordered published and to com up for second read the ing and final passage at the regular meeting to be held June 6th 1923 at 7.30. o, clock, P.M.
