The minutes of the meetings of the City Council held April 1st 18th, 29th were read and approved.

The communication of the Board of Water Commissioners relative to Water Superintendent taking proper care of drinking fountains in Oregon City was read and ordered placed on file.

The communication from the Board of Tater Commissioners relative to placing the City Municipal leevator under electric power instead of water power for the operation thereof was read and referred to a special committee composed of Tobin, Templeton and Van Auken.

The following report of the street committee relative to hard surfacing streets in Oregon City was read and adopted:

Oregon City, Oregon, June 5th, 1918.

Hon. Mayor and City Council of Oregon City, Oregon.

Gentlemen:-

We, your street committee, having investigated the question of hard surfacing of streets in the City, recommend that a hard surface similiar tothat laid on Molalla Avenue last summer, be used.

Using a mixture of XX petrolistic cement and Grade "E" asphalt heated, mixed in proper proportion and spread on the stone hot in two layers of about an inch each.

This material to be laid on Seventh Street, Washington Street from the Abernethy Bridge to Fourteenth Street and Fourteenth Street from Washington to Main Street.

We also recommend that the Abernethy Bridge of the Portland Railway. Light and Power Company be decked with 3 inch lumber and 2½ inches of Clackamas County Paving (Warswick type) to baid over the plank.

The cost of the improvement will be \$600.00 for the bridge. For Fourteenth Street 16 foot roadbed 600.00 For Washington Street same 1300.00 For Seventh Street 30 foot road bed 450.00 per block.

16 foot wide will cost \$ 380.00 per block.

To put down this paving it will be necessary to purchase a climax haeting distributor at \$1400.00 and a scarifier at \$2......

We recommend that this work be done as far as the funds will allow.

Gentlemen:

YourFinance Committee having fully considered the increse of wages for each member of the police department, the Street Superintendent

and Engineer.

We recommend that the chief of police and the two night men be increased \$15.00 each per month beginning Junel-1918, and that the sum of \$315.00 being a sufficient sum to make said raises, be taken from the emergency fund to cover said increased cost.

That the Street superintendent be raised \$10.00 per month and that said incrase be taken care of by the Street department Budget which can be done due to the change of employing street and sewer labor at our last meeting.

And the City Engineer be advanced from \$5.00 to \$6.00 per day and the incrase be taken sare of by the money setaside bythe Budget for Engineering Purposes.

The following ordinance entitled "Ordinance No.\_\_ An Ordinance to prevent malespersons between the ages of 16 and 60 years in Oregon City, who are physically fit to perform some useful service from remainingidle during the period of the war, providing a penalty. " was read first time and ordered published and to come up for second reading and final passage at a special meeting of the said city council to be held on the 18th day of June, 1918, at 7:30 o'clock, p.m.

This being the time for the election of a member of the Board of Water Commissioners, Mr.Mort Latourette was placed in nomination and there being no further nominations made, the Recorder was instructed to cast an unanimous ballot for Mr. Latourette and he was declared the duly elected member for the ensuing term.

The Mayor was asked to have the trees in the City Parks sprayed, the matter was left in the hands of the Mayor with power to act.

The Council with the City Attorney discussed the proposed new charter.

On motion the council adjourned.
