The City Council of Oregon City Oregon met in special session on the above date at the council chamber at 7,30. O, clock P.I.

Layor James Shannon in the chair, Rall Call showed the following present, Albright, Bridges. Cross, VanAulin. Krassig, Mount, Fetzold. Metzner. Absent. none,

The Following ordinances were read.
An Ordinance for the improvement of Harrison street Oregon City
Oregon.from a point at the south side of Sixteenth Street southerly
to the south side of Fifteenth Street. and declaring an emergency.

An Ordinance, for the improvement of Harrison Street Oregon City Ore on from the south side of seventh street to the south side of Division street , and declaring an Emergency.

An Ordinance appropriating the sum of \$245,04 out of the General Fund, in payment of amount do to the W D Andrews Construction Co. for the extinion of Twelth street sever, and declaring anemergency

In Ordinance, for the improvement of Fifteenth Street Oregon City Oregon. from a point at the northeast corner of Fifteenth and Harrison Streets Thaterly to the West side of Division Street and declaring An Exergency.

An Ordinance, for the improvement of Front Street in Green Point Oregon City Oregon, from a point 150 feet west of Moss Street Easterly to the center line of the Southern Pacific Railroad trackend declaring an emergency,

On Motion, it was voted to declare this the second reading and placed up on there final passage, it appearing from the certificat of Don Wilson principal clerk of the publisher and printer of the Banner-Courier that the same were properly published As required by the charter, and on **EXELUATION** Motion and roll call the vote Resulted as follows, Ayes, Albright, Bridges, Cross, VanAukin, Krassig. Mount, Petrold. Metrner. Noes, none. Absent, none

A communication from the Enterprise Pub. Co. asking that permission be granted to withdraw their bid for the legal printing as submitted. On motion was granted,

It was voted to accept the bid of the Banner Courier for the legal City Printing for the ensuing Six Honths, and was so ordered.

A bill for the 1920 taxes on the Auto Fark was submitted by the F.R.G.L.Co, for #XXX 9317.81 same was referred to the Street Committee and City Attorney.

A lease and ordinance, was submitted by Frank Busch and Sons to the council asking permission to sublet their lease to J.Simon and Brother, for the balance of of the term of the lease held by them.

Cross moved that the proposition be rejected, the vote resulted as follows,
Ayes, Albright, Cross, VanAukin, Krassig, Metzner, (5)
Noes, Bridges, Mount, Metzner, (30)

In the Matter of the 12th street bridge, The Engineer submitted plans for same and the Recorder was instructed to advertize for bids for the construction of same,

It was voted that the Street Supt, fix the cross walk at twelth and Center street,

The City Engineer was instructed to make an estimate of the cost for a ferry landing at the west end of twelth Street.

The Mayor, appointed Mr John Bradley to act as appraiser in place of Mr EG Caufield who is leaving the city for a short time and will be unable to act, as appraiser for the 12th street and and alley improvement in Block 24.

Mr 1 R Noble appeared before the council and asked that permerssion he gr nted the Boucher Carnival Co, to hold a carnival for F

Five days between 5th and 6th on Water street, on a percentage basis,
For the benefit of The Oregon City Fire Dept.
Permission was granted to the Firemen with power to get all the percentage they could,

The Report on the Seventh Street improvement by the Engine r was accepted and warrant Ordered drawn in payment of same,

A certificate of the City Engineer accepting 12th street and the alley in Block 24 in the form hereinafter set out was filed. and on motion the following resolution was adopted.

I herby certify that the paving of twelth street of Oregon City Oregon from the Westerly line of Center Street to the Easterly line of Main street. and the Alley in Block 24, from the westerly line of Railroad avenue, to the Easterly line of Main street, has been fully completed by W J Andrews construction Co, to my satisfaction, and I hereby approxe the same.
