It was voted that the 80% of the Contract for the Improvement of Willamette St, from Warren to Eluria street be Paid to the contractor D?D?Bain, . of the Falls Transfer Co. Ayes, Andresen, Caufield, Cross.

The Appointment of Dr. Frank Wallace. was made to act as City Health Offiver for the Year 1925, and that the Salary for said officer to be Paid by the County,

Notices showing that the apportionment of the cost of the improvement of Roosevelt Street from Molalla Ave, to the Alley in Block 14 Holmes Addition and Willamette Street from Warren st, to Eluria St had been properly published and no ob jections having been filed to the said Assessments,

The following Ordinance WAM Was read. An Ordinance declaring the asses sment MAX for the improvement of Willamette Street from the west side of Warren st, to the East side of Eluria st, in Dregon City Oregon. An Ordinance granting to the Oregon & California Rail Road Company, its lessees, successors, and assigns and O.E.Meindle the right, privledge, permission, and franchise to construct and lay down, maintain, and operate an industrial spur track upon and along Center Street and across Sixteente Streer in Oregon City Oregon. came up for first reading and it was voted to consider this the first reading and that the same be ordered published and to come up for second Reading and final passage at a meeting to be held on the 21st day of January 1925 at 1,0,clock. P.M.

A Remonstrance objecting to the acceptancoofiWillamette Street filed January Llothilg25hwas read, and as the time for filing said objectins, had expired, no action could be taken on the remonstrance,

An Application for the installation of a Gas Tank by the Park-Sheph erd Co, in front of their place of business on fifth, was read and onmotion permission was granted,

A petition objecting to the Spending \$2500.00 to the retention of the Eight Street Steps was read and ordered placed on file.
