December 1st, 1915.

The City Council of Oregon City, Oregon, met in regular session on the above date at 8 o'clock, p.m.

The minutes of the meetings of the city council held on the 8th, 10th, 17th, and 26th of November, 1915, were read and approved.

The application for a refund for \$5.00 of J. J. Bullock for a part of a lot the city used at the cemetery was laid on the table and the Recorder was ordered to notify him to that effect.

The application of John C. Knapp to have the catch basin and drain along Main Street attended to was referred to the committee on streets and public property.

The communication of Mr. F. I. Fuller of the Portland Railway, Light and Power Company was read and the request was granted provided that the city waives no legal rights and provided that the Railway Company be responsible whether successful or unsuccessful in remedying defects, and provided further that if remedy is successful that the Railway Company improve the street uniformly between Second and Eleventh Streets at the request of the City Council and under the supervision of the City Engineer.

Invitation of the Live Stock association at the Stock Yards in Portland was read and laid on the table.

The communication of Miss Daisy Larsen by her attorney, O. W. Eastham, offering \$168.50 cash as settlement in full of Eleventh Street improvement liens on Lots 3 and 4, Block 144, was accepted with the understanding that the assessment on said property for the improvement of J. C. Adams Street be paid in full according to the Bancroft Bonding Act.

The communication of Cellars-Murton Company asking that their High Street warrant in the sum of \$517.11 be paid by the cash on hand in the treasurers office and the balance with a General Fund warrant was referred to the Finance Committee.

The communication of the Finance Committee with reference to the exchange of two Jackson Street Warrants No. 21 and 22 to the General Fund was adopted.

The communication of the Contractors Supply Company together with a claim against the Standard Paving Company in the sum of \$ 158.50 was read and ordered placed on file.

The communication of the Portland Railway Light & Power Company, in regard to the planking of the Abernethy Bridge was referred to the committee on streets and public property.

The declaration from the Pure Mountain Water League Commission stating that the water pipe line from the South Fork of the Clackamas River to Oregon City had been completed was ordered filed and the request of the commissioner for more time in which to file their December report was granted.

The communication from the Secretary of the Water Commission stating that Fred McCausland had resigned to take effect on Jan. 1-1916 was ordered filed and the resignation accepted.

The report of the City Pound master for the month of November 1915, was read and ordered filed.

The report of the Chief of Police for the Month of November, 1915 was read and ordered filed.

The monthly report of the City Recorder was read and ordered filed.

The following ordinance entitled "Ordinance No. \_\_\_ An Ordinance declaring the assessment for the improvement of Tenth Street, Oregon City, Oregon, from the east line of Main Street to the right-of-way of the Southern Pacific Railway Company" was read first time and ordered published and to come up for second reading and final passage at a special meeting of the said city council to be held on the 15th day of December, 1915, at 5 p.m.

The following ordinance entiteld "Ordinance No. \_\_\_ An Ordinance declaring the assessment for the improvement of John Adams Street, Oregon City, Oregon, from the South line of Seventh Street to the North line of Fourth Street" was read first time and ordered published and to come up for second reading and final passage at a special meeting of the said city council to be held on the 15th day of December, 1915, at 5p.m.

The following ordinance entitled "Ordinance No. \_\_\_ an Ordinance declaring the assessment for the improvement of Third Street, Oregon City, Oregon, from the East line of Main Street to the Southern Pacific Viaduct" was read first time and ordered published and to come up for second reading and final passage at a special meeting of the said

The following ordinance entitled Ordinance No. \_\_\_ An Ordinance appropriating the sum of Three Hundred (\$300) dollars or so much thereof as may be necessary for the construction of a sidewalk from Oregon City to Mt. Pleasant and authorizing the Mayor and City Recorder to enter into a contract for the construction of said sidewalk" was read second time and placed upon its final passage and it appearing from the certificate of Malva Bolle, principal clerk of the publisher and printer of the Morning Enterprise that the same has been properly published as required by the charter and on motion and roll call the ordinance passed, the vote being as follows:

The following ordinance entitled "Ordinance No. \_\_\_ An Ordinance vacating the alley running through Block Sixty-Three (63) Oregon City, Oregon." was read second time and placed upon its final passage and it appearing from the certificate of Malva Bolle, principal clerk of the publisher and printer of the Morning Enterprise that the same had been properly published as required by the charter and on motion and roll call the ordinance passed, the vote being as follows:



The question of an arc light on Singer Hill was referred to the committee on streets and public property.

Mrs Newton appeared before the council in regard to an adjustment of her city liens on J. A. Adams Street, Sixth Street and on Monroe Street and the committee to whom the matter was referred was given further time in which to report until December 8th, 1915, in which to prepare an itemized statement.

At this time was considered the question of the election of a member of the Board of Water Commissioners, caused by the vacancy and resignation of Mr. Fred McCausland, the name of L. E. Jones, the present Mayor was presented and on motion of the council, with Mr. Meyer, president of the council in the chair, it was voted that the said L. E. Jones be appointed a member of the Board of Water Commissioners to take effect January 1st, 1916.
