The City Council of Oregon City, Oregon, met in special session on the above date at 7:30 o'clock, p.m.

The Mayor called the meeting to order and the Council resolved itself into a committee of the whole for the purpose of the canvass of the vote of the regular election, held on the 7th day of December, 1914.

Gentlemen:-We, Your committee of the whole, having been appointed to canvass the vote and election returns of the general city election held in Oregon City on the 7th day of December,1914, upon arising from sitting as such committee heg to report as follows: Whole number of votes cast for Mayor in Wards 1,2,3, at said election Linn E.Jones received of same 709 yotes.

JONES, Mayor of Oregon City,Oregon, do hereby proclaim that an Act entitled "A Bill for An Act to proivde a wethod of foreclosing special city assessments and liens against real property in the City of Oregon City,Oregon, in the Circuit Court of the State of Oregon for the County of Clackamas, where the property has been offered for sale and no bids have been received therefor" was submitted to the legal voters of Oregon City,Oregon, for their approval or rejection at a regular city election held on the 7th day of December, 191:, and that at said election the whole number of votes cast were 998 votes, and the said votes cast for said act were 520 votes, and the whole number of votes cast against srid act were 478 votes.

I therefore declare the said act duly approved, passed and carried and now a part of the charter and fundamental law of Oregon City.

The City Attorney stated that under the charter a number of city improvements were in a state of completion sufficient to allow the City Engineer to certafy to the total cost of same and on vote of the Council, it was ordered that the City Engineer as soon as possible prepare certificate of cost of all streets and sewers to do so in accordance with Section 102 at page 39 of the charter of Oregon City.

Mr.Verweyst again appeared before the Council in the interest of sewer connection with his property and the Council reconsidered its former action and appointed a committee consisting of Councilmen: Meyer and Templeton to investigate same and report at their pleasure at

a later meeting.

Mr.Trimble called attention to the dangerous condition of several improved streets needing guard rails along the sidewalks, by vote of the Council the matter was referred to the street superintendant with instructions to notify all property owners to construct proper guard rails On motion/the Wuncil adjourned. on any street where dangerous.
