March 17th 1922

The City Council met in special session on the above date at the council chamber at 8,30 o'clock P.M. With Mayor Shannon in the chair  
 Roll call showed the following councilmen present.

J E Jack, I.C.Bridges, F H Cross, E D VanAukin, Dr.H.S.Mount, F.Metzner  
 R.Petzold. Absent, Wm Krassig.

The Mayor stated that the purpose of the meeting was to consider certain ordinances and to listen to objections against the appraisers report on the sixth street sewer in Dist No. 13. and any other business that may come before the council.

An Ordinance authorizing the issuing of improvement Bonds for the improvement of 12th Street, 8th Street and alley in Block 24 was read the second time and affidavit showing that same had been properly published according to law. ~~xxx~~ On Motion it was voted to consider the same the second reading and that the ordinance be placed on its final passage  
 The Vote resulting as follows.

Ayes, Jack, Bridges, Cross, VanAukin, Mount, Metzner, Petzold,  
 Noes, none. Absent, Krassig.

An Ordinance Establishing the grade of Molalla Avenue from a point at the intersection of Duane Avenue to the City limits of Oregon City,  
 Was submitted for second reading and final passage  
 Affidavit showing that the ordinance had been properly published according to law, on Motion it was placed on its final passage and the vote resulted as follows.

Ayes, Jack, Bridges, Cross, VanAukin, Mount, Metzner, Petzold.  
 Noes None. Absent, Krassig.

That part of From Main to Water Street  
 Notice of the Engineer that the Sixth Street Pavement has been completed and that the council had set the 17th day of March as the date to hear or file objections to the acceptance of said improvement,  
 There being no objections. The Report was adopted.

An Affidavit from the Banner Courier Showing that a Notice of hearing of objections to the benefits of the property in Sewer Dist No. 13 and the assessments based thereon, was read and there being no objections the same was ordered placed on file and the City Attorney instructed to draw an ordinance confirming same.

Councilman Bridges suggested that the Street Dept, be furnished with Hose, for flushing Sewers, ect, The Mayor stated that the Fire dept should turn over all discarded hose that could be used for said purpose to the Street Supt for the use of his Department.

An Application for a Gas Tank to be installed by the Oregon City retreading works in front of lot 4 Block 9 was submitted and on Motion it was voted that permission be granted And so ordered.

A bill was presented by O D Eby for the Expense of the trial of Doty Vs. Oregon City. and expense of \$3.56 for trip to Salem in interest of the City Total Amount \$24.00 On recommendation by the Finance Committee it was voted that a warrant be ordered drawn in payment of said bill. and so ordered.

In The matter of the City using that part of the sewer that crosses Main Street at Sixth. Which was put in by Stevens & Howell They felt that the City Should reimburse them for allowing the City to use that part of their improvement on motion it was voted That a Warrant for the sum of \$63.22 be drawn in payment of said claim. and so ordered.

A communication from the State High Way Commission insisting that early action be taken in the matter of the connection of the Pacific Highway with the City was read and on motion by Mount The Recorder was instructed to ask the Commission to set a time and date so that the matter could be taken up by a committee of the Council.

Chairman Cross of the committee on Health & Police suggested that the City Purchase a Motor Cycle for the Police Dept so that they would be better ~~XXX~~ equipped to enforce the Traffic laws. On Motion that the City Purchase a Motor Cycle. the vote resulted as Follows.  
Ayes. Bridges. Cross. (2)  
Noes. Jack. VanAukin. Mount. Petzold. (4)  
Absent, Krassig. Metetzner having been excused.

The City Council of Oregon City Oregon met in Regular session on the above date at the council chamber at the hour of 7.30 o'clock P.M. With Mayor James Shannon in the chair, and the Roll call showed the following present Jack, Bridges, Cross, VanAukin, Krassig. Mount, Metzner. Petzold.

The Minutes of the previous sessions were read and approved.

A Communication from the Secy, Masonic Lodge, stating that the rent for the Recorder and The Engineers Office would be raised from \$15.00 a month to \$ 20.00 a month beginning May 1st 1922 On Motion by Metzner. it was ordered that the offices be moved in to the City hall building before May 1st

Communication from Warren and Blodgett ask that permission be granted to place an air station in front of their place at 407 Main Street On Motion same was Granted.

Communication from the Gas & Coke Co. stating that their Permit Bond was executed by the Oregon Surety and Causality Co, same to be in force for the year ending April 15th 1923. on motion same was ordered placed on file.

The Report of the City Treasurer, Chief of Police, and City Recorder, Were read and on motion were placed on file.
