The East Side Railway Company

The franchise of the East Side Railway Company, granted to it under the provisions of ordinance No. 139, of Oregon City, Oregon, more particularly described as follows, to-wit: Beginning at a point 2.15 feet east of the center line of Main street at its intersection with the north line of Third street, said point being one foot west of the west rail of said company's track; thence northerly and northeasterly parallel with and one foot from the west rail of said company's track to the north line of Fourteenth street in said Oregon City, thence easterly at right angles to said company's track 7 feet; thence southerly parallel with east rail of said company's track, and one foot east of it to the north line of Third street in said city; thence at right angles westerly 7 feet to place of beginning; with all switches and turnouts, and all privileges and easements, accrued or accruing under the provisions of said ordinance. An ordinance read the first time and ordered published declaring the assessment for the improvement of Main street.
