

Council Chamber, Oregon City, Ore.
September 24th, 1920.

The City Council of Oregon City, Oregon, met in special session on the above date at 7:30 p.m. in prusuance of a callof the Mayor.

Roll call showed the following officers present:

The Mayor stated that the purpose of the meeting was for the report of the Fire & Water Committee.

The report of the special committee relative to the amount wanted for the Schram lot on 6th & Water Streets was read and stated that Mr. Scrahm would accept \$ 5000.00 and the City's lot 8, Block 15 for said property. It was voted to place the said report on file.

The votedresulted in a tie as follows:

Ayes: FAlbright, Bridges, Green, Eby.

Noes; Kelly, Krudger, Petzold & Tobin,

The Mayor casting the deciding vote favoring the same.

A petition for the reorganization of the fire department was presented from the fire department of Oregon City and the matter was referred to a committee to confer with the said fire department and report back to the Council. The committee appointed being: Bridges, Eby and Kelly.

A communication from the State industrial accident commission was read and the matter was referred to the finance committeee to be taken with the water board and report estimate of cost of same.

A communication was read of all the property owners interested in the adjacent property asking that all parking be discontinued on 7th Street between Main Street and Railroad Avenue and it was voted that the city attorney prepare an ordinance for same for October 6th, 1920.

Permission was granted the Portland Gas Company to open up Main Street near the Bank of Oregon City to find gas leak.

A committee of three was appointed to negotiate city bonds: Tobin, Kelly and Petzold.

The matter of the elevator advertising was left in the hands of the street committee with power to act.

The matter of the 12th street sidewalk was referred back to the street committee for a definite report at the next meeting of the city council.

Caleb Cross was granted permission to cut tree in 8th Street between Washington & John Adams Streets.

Mr. Wm Howell complained of the muddy streets and the mud on the sidewalks in Oregon city, and the matter was referred to the street supt. and the committee on streets and public property.

A party offered to buy lots on 16th & Jackson Streets. No action was taken,

Mr.Dicken offered to buy lots 7 and 8, Block 145, matter laid over til next meeting.

Mr.Streibig stated that he had had to pay \$ 133.00 for repairing of the city scales and it was voted that he keep all the proceeds of same until he was repaiñ the said amount.

On motion the council adjourned.
