Special Meeting

The City Commission of Oregon City, Oregon, met in Special session on the above date in the office of the City Manager at the hour of One o'clock p.m. with Mayor Pace in the Chair.

Roll Call showed the following present: Pace and Caufield, commissioners, and City Manager Franzen.

The Purpose of the Meeting was for the passage of certain ordinances.

Ordinance No. 1165, An ordinance declaring the assessment for the improvement of the following named streets: Monroe Street, from the south side of Fourth St. to the south side of Fourteenth St., Sixth Street, from the east side of High Street to the west side of Jackson Street, Water Street, from the south side of the Alley running through Block 3 to the north side of the Alley running through Block 6., was read first time and on motion ordered

ORDINANCE NO. 1165

An ordinance declaring the assessment for the improvement of the following named streets:

Monroe Street, from the south side of Fourth Street to the south side of Fourteenth Street,

Sixth Street, from the east side of High Street to the west side of Jackson Street.

Water Street, from the south side of the Alley running through Block 3 to the north side of the Alley running through Block 6.

OREGON CITY DOES ORDAIN AS FOLLOWS:

Section. 1. The Assessment for the improvement of the following streets in Oregon City, Oregon, has been levied and declared and declared according to Assessment Rolls, and the total cost thereof, as hereinafter stated.

Monroe Street, from the south side of Fourth Street to the south side of Fourteenth Street,
Assessment Roll No. 1927 D. Total Cost \$19,774.27.

Sixth Street, from the east side of High Street to the west side of Jackson Street.
Assessment Roll No. 1927 E. Total cost \$11,882.69.

Water Street, from the south side of the Alley running through Block 3, to the north side of the Alley running through Block 6,
Assessment Roll No. 1927 C. Total Cost \$6,318.36.

Section 2. Whereas, the condition of said street was dangerous to the health and safety of the people of Oregon City, and the public and it is necessary for the immediate preservation of the health, and safety of the people of Oregon City that this ordinance shall be in full force and effect immediately upon its passage and approval by the Mayor.

Read first time and ordered published at a special meeting of the City Commission of Oregon City, Oregon, held on the 27th day of September, 1927, and to come up for second reading and final passage at a special meeting of the City Commission to be held on the 6th day of October, 1927, at the hour of one o'clock p.m.

ORDINANCE NO. 1166

An ordinance declaring the assessment for the cost of Sewer District No. 21.

OREGON CITY DOES ORDAIN AS FOLLOWS:

Section 1. The assessment for the cost of Sewer District No. 21 has been levied and declared according to Assessment Roll No. 1927 G. Total cost \$1,707.38.

Section 2. Whereas, the territory embraced by the proposed district is thickly settled and was without proper sewerage and drainage, which was a menace to the health and safety of that district and the people of Oregon City, and it is necessary for the immediate protection of the health and safety of the people of that district and Oregon City, that said sewer was constructed.

An emergency is hereby declared to exist and this ordinance shall take effect and be in full force immediately upon its approval by the Mayor.

Read first time and ordered published at a special meeting of the city commission held on the 27th day of September, 1927, and to come up for second reading and final passage at a special meeting to be held on the 6th day of October, 1927 at the hour of one o'clock p.m.
