Special Meeting

The City Commission of Oregon City, Oregon, met in special session on the above date in the office of the City Manager, Municipal Building, at the hour of one o'clock p.m. with Mayor Pace in the Chair.

Roll Call showed the following present: Pace and Farr commissioners, and City Manager Franzen.

The following resolution calling for a special election for the annexation of Canemah, was read and adopted:

RESOLUTION

WHEREAS, a petition has been filed containing more than one-fifth of the qualified electors of Oregon City as shown by the votes cast at the last municipal election held in Oregon City requesting that a special election be called for the purpose of extending the boundaries and annexing the following described territory to Oregon City, to-wit:

Beginning at a point on the Southeasterly side of Center Street in Oregon City, Oregon, where said side line intersects the Southwesterly boundary of the present City limits of Oregon City; thence following the said side line of said street as platted in Oregon City and in Field's Addition to Oregon City, Plat Records of Clackamas County, Oregon, to the intersection of said side line with the Southerly boundary of Section 31, Tp. 2 S., R 2 E, W.M. running thence to the Southeasterly corner of Block 56 of Canemah, as shown by the plat records of Clackamas County, Oregon; thence following the Southeasterly side line of Canemah as platted to the Southeasterly corner of Block F of Canemah; thence in a northwesterly direction along the westerly line of Blocks F, G, H, and I, produced, as shown by the plat records of Clackamas County, Oregon, to the center of the Willamette River; thence following the center of the Willamette River down stream to the most Southwesterly corner of the present City limits of Oregon City as incorporated; thence Southeasterly to the place of beginning.

Therefore, Be It Resolved by the City Commission that a special election be held on the 18th day of August, 1928, in the territory to be annexed and in the City of Oregon City to determine whether such territory be annexed.

Due to an error in Ordinance No. 1185, the same was corrected to read as follows, and was read first time and ordered published.

ORDINANCE NO. 1185

An ordinance for making an improvement of South Second Street, from the west side of High Street to the east side of Hawley Avenue

in Oregon City, Oregon

OREGON CITY DOES ORDAIN AS FOLLOWS:

Sec. 1. That the proposed improvement of South Second Street, from the west side of High Street to the east side of Hawley Avenue in Oregon City, Oregon, shall be made according to Improvement No. 1, according to the plans and specifications on file in the office of the City Recorder of Oregon City, Oregon, and approved by resolution adopted on the 29th day of May, 1928, by the City Commission of Oregon City, which said plans and specifications are hereby referred to and made a part of this ordinance. The improvement shall be constructed as follows:

The street shall be brought to subgrade between the curb lines of said street from the west side of High Street to the east side of Hawley Avenue. On the roadbed shall be placed 2 inch Asphaltic Concrete wearing surface. Said street where required according to plans and specifications, shall be provided with concrete curbs 6 x 8 x 18 inches on each side of said street.

The street shall be properly provided with drains and gutters necessary to provide proper drainage for the street.

All of said improvement shall be made according to the plans and specifications which are hereby referred to and made a part of this ordinance, and which were filed on the 5th day of May, 1928, in the office of the City Recorder and which plans and specifications and estimates are hereby approved.

Sec. 2. The improvement shall be classed as Asphaltic Concrete and shall be maintained by Oregon City for the full period of ten years from the date of the acceptance thereof by the City Commission.

Sec. 3. The Mayor and City Recorder are hereby authorized and instructed to enter into contract with L. O. Herrold for the improvement hereinbefore specified. The contract to contain a stipulation to the effect that where the cost of the improvement under the provisions of the contract shall exceed one-half of the value of the property assessed for the cost of the improvement, that the said excess shall be paid out of the General Fund of Oregon City, Oregon, and as to the balance, the contractor shall look for payment to the sum assessed upon the property liable to pay for said improvement, and collected and paid into the City Treasury of Oregon City, for such purpose, and they shall not hold Oregon City by any legal process or otherwise to pay the said sum out of any other fund.

Whereas, the condition of said street is such that it is necessary to make the improvement as soon as possible to preserve the peace, health and safety of the inhabitants of Oregon City, an emergency is hereby declared, and that this ordinance shall take effect and be in force immediately upon its approval by the Mayor.

Read first time and ordered published at a special meeting of the city commission held on the 14th day of July, 1928, and to come up for second reading and final passage at a special meeting of the city commission to be held on the 24th day of July, 1928, at the hour of one o'clock p.m.
