State Revenue Sharing law requires cities to pass an ordinance each year stating that they want to receive State Revenue Sharing money. The law also requires that the City certify that two budget hearings were held.

One budget hearing on State Revenue Sharing is to be held before the Budget Committee, while the second public hearing must be held before the City Commission. Both of these public hearings must be certified to the Accounting Division before July 31, 1993. On May 17, 1993, the City complied with the first requirement, with the public hearing before the City Commission held on June 30, 1993.

On the agenda for the July 21, 1993 Commission meeting is proposed Ordinance No. 93-1012 (copy attached) which declares that Oregon City elects to receive State Revenue Sharing money.

Notice of proposed Ordinance No. 93-1012 was posted at City Hall, Courthouse and Senior Center, by direction of the City Recorder. Based upon the above information, it is recommended that first reading be approved; second reading be called and approved for final enactment to become effective August 20, 1993.
