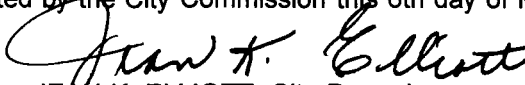
AN ORDINANCE AMENDING TITLE 10: VEHICLES AND TRAFFIC, CHAPTER 10.36: IMPOUNDMENT OF VEHICLES, SECTION 10.36.090: UNINSURED VEHICLE HEARING PROCEDURE, OF THE OREGON CITY MUNICIPAL CODE OF 1991

OREGON CITY ORDAINS AS FOLLOWS:

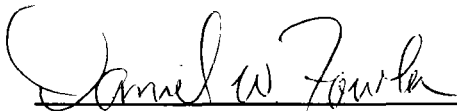
Section 1. That Title 10: VEHICLES AND TRAFFIC, Chapter 10.36: IMPOUNDMENT OF VEHICLES, Section 10.36.090: UNINSURED VEHICLE HEARING PROCEDURE, of the Oregon City Municipal Code of 1991, is hereby amended to read as follows:

10.36.090 Uninsured vehicle hearing procedure. A. A person entitled to lawful possession of a vehicle impounded under Section 10.36.080 may request a hearing to contest the validity of the impoundment. A request must be made within ten (10) calendar days of the impoundment. The request shall be made to a person designated by the impounding police agency to receive such requests.

Read first time at a regular meeting of the City Commission held on the 6th day of March, 1996, and the foregoing ordinance was finally enacted by the City Commission this 6th day of March, 1996.

Subject: Proposed Ordinance No. 96-1001, An Ordinance Amending Title 10: Vehicles and Traffic, Chapter 10.36: Impoundment of Vehicles, Section 10.36.090: Uninsured Vehicle Hearing Procedure, of the Oregon City Municipal Code of 1991

Report No. 96-17

At its November 1, 1995 meeting, the City Commission adopted Ordinance No. 95-1025 which amended City Code, Title 10 by adding a new Chapter 10.36 entitled "Impoundment of Vehicles". Contained within Chapter 10.36.060 "Hearing Procedures—Owner Liability" there is ten (10) calendar day provision for a request for hearing to contest the vehicle impoundment.

Contained within Chapter 10.36.090 "Uninsured Vehicle Hearing Procedure" is a five (5) calendar day provision for a request for hearing to contest the vehicle impoundment.

On the March 6, 1996 agenda is proposed Ordinance No. 96-1001 (copy attached) which amends Section 10.36.090 of the City Code by changing the second sentence of Chapter 10.36.090, subsection A to read: "A request must be made within ten (10) calendar days of the impoundment. The five (5) calendar days was an oversight. The proposed change will bring consistency to the procedure.

Notice of proposed Ordinance No. 96-1001 was posted at City Hall, Pioneer Community Center and Municipal Elevator by direction of the City Recorder. It is recommended that first and second readings be approved for final enactment to become effective April 5, 1996.
