It is understood and agreed that no building shall be erected upon said easement premises without the written consent of GREGOR CITY, a municipal corporation, and that the said City shall replace, as near as practicable, the surface of said easement premises after construction and maintenance work on said sewer.

This instrument does not grant or convey unto GREGOR CITY, a municipal corporation, any right or title to the surface of the soil along the route of said sewer except for the purpose of laying, improving, maintaining and replacing the same.
