> The southerly 15 feet of the westerly 15 feet of Lot 13, Block 12, MOUNTAIN VIEW ADDITION TO OREGON CITY, according to the duly recorded plat thereof.

There is also granted herewith a construction easement of an additional 15 feet in width on <u>northerly & easterly</u> sides of the above described permanent easement for use during the construction of said sever, which right shall cease when the construction of said sever is completed.

It is understood and agreed that no building shall be erected upon said easement premises without the written consent of ONEGON CITY, a municipal corporation, and that the sai City shall replace, as near as practicable, the surface of said easement premises after construction and maintenance work on said sever.
