PETERSON, widow of Carl Peterson, and unmarried hereinarter referred to as the Granter, in consideration of the sum of <u>Eichteen and no/100</u> (\$18.00) ______ paid by OREGON CITY, a municipal corporation, which sum is hereby acknowledged and receipted by the Granter, do hereby grant unto OREGON CITY, a municipal corporation of Clackamas County, Oregon, an easement and right to lay, construct, reconstruct and perpetually maintain a sever through, under and along the following described property in Oregon City, County of Clackamas and State of Oregon:

> That portion of Lot 12, Block 12, MOUNTAIN VIEW ADDITION TO OREGON CITY, according to the duly recorded plat thereof, lying within the boundaries of a strip of land 15 feet in width, being 7.5 feet on each side of the following described centerline: Beginning at a point on the north property line of said lot a distance of 5 feet east of the northwest corner; thence south 53° 54' east a distance of approximately 82 feet to a point on the south property line of said lot.

There is also granted herewith a construction casemont of an additional 7.5 feet in width on each side of the above described permanent casemont for use during the construction of said cover, which right shall cease when the construction of said sover is completed.
