## Deed Reference:

KNOW ALL MEN BY THESE PRESENTS, That JENNIE M. EVERHART, widow of George F. Everhau and unmarried; and LISLE A. CURRAN and WILMA CURRAN, his wife, hereinafter referred to as the Grantor, in consideration of the sum of <u>Six and no/100 (\$6,00) - - - - paid</u> by OREGON CITY, a municipal corporation, which sum is hereby acknowledged and receipted by the Grantor, do hereby grant unto OREGON CITY, a municipal corporation of Clackamas County, Oregon, as easement and right to lay, construct, reconstruct and perpetually maintain a server through, under and along the following described property in Oregon City, County of Clackamas and State of Oregon:

> That portion of Lot 12, Block 12, MOUNTAIN VIEW ADDITION TO OREGON CITY, according to the duly recorded plat thereof, lying within the boundaries of a strip of land 15 feet in width, being 7.5 feet on each side of the following described centerline: Beginning at a point on the north property line of said lot a distance of 5 feet east of the northwest corner; thence south 53° 54' east a distance of approximately 82 feet to a point on the south property line of said lot.

There is also granted herewith a construction casement of an additional 7.5 feet in width on each side of the above described permanent easement for use during the construction of said sever, which right shall cease when the construction of said sever is completed.

It is understood and agreed that no building shall be erected upon said casement premises without the written consent of OREGON CIFY, a municipal corporation, and that the sai City shall replace, as near as practicable, the surface of said comment premises after con struction and maintenance work on said sever.

This instrument does not grant or convey unto OREGON CITY, a municipal corporation, an right or title to the surface of the soil along the route of said sewer except for the purpose of laying, inspecting, maintaining and replacing the same.

TO HAVE AND TO HOLD said easements and rights unto OREGON CITY, a municipal corporatio for the uses and purposes herein mentioned.
