A part of Lots 1 and 2, Block 3, River Crest Addition to Oregon City, Oregon, according to the duly recorded plat thereof, described as follows:

Beginning at a point on the Southerly boundary of Lot 1, Block 3, of said River Crest Addition to Oregon City, Oregon, which point is 83.33/West of the S.
