CITY OF OREGON CITY, OREGON PUBLIC UTILITY(S) EASEMENT

KNOW ALL BY THESE PRESENTS, THAT <u>Oregon City School District</u> hereinafter called the GRANTOR, do(es) hereby grant unto the City of Oregon City, hereinafter called the CITY, its successors in interest and assigns, a permanent easement and right-of-way, including the permanent right to construct, <u>sidewalks</u> on the following described land:

Exhibit "B" Sketch for Legal Description

TO HAVE AND TO HOLD, the above described easement unto the CITY, its successors in interest and assigns forever.

GRANTOR reserves the right to use the surface of the land for walkways, plantings, parking, and related uses. Such uses undertaken by the GRANTOR shall not be inconsistent or interfere with the use of the subject easement area by the CITY. No building or utility shall be placed upon, under, or within the property subject to the foregoing easement during the term thereof, however, without the written permission of the CITY.

Upon completion of the construction, the CITY shall restore the surface of the adjacent property to its original condition and shall indemnify and hold the GRANTOR harmless against any and all loss, cost, or damage arising out of the exercise of the rights granted herein.

The true consideration of this conveyance is \$1.00, the receipt of which is hereby acknowledged by GRANTOR.

And the GRANTOR above named hereby covenants to and with the CITY, and CITY's successors in interest and assigns that GRANTOR is lawfully seized in fee simple of the above granted premises, free from all encumbrances (no exceptions)

and that GRANTOR and their heirs and personal representatives shall warrant and forever defend the said premises and every part thereof to the CITY, its successors in interest and assigns against the lawful claims and demands of all persons claiming by, through, or under the GRANTOR.

In construing this deed and where the context so requires, the singular includes the plural and all grammatical changes shall be implied to make the provisions hereof apply equally to corporations and to individuals.

Permanent Right of Way Easement For Road Purposes:

A parcel of land, as shown on attached Exhibit "B" which by this reference is made a part hereof, being a portion of the George Abernathy D.L.C. No. 58, in the northeast 1/4 of Section 28, Township 2 South, Range 2 East, of the Willamette Meridian, Clackamas County, Oregon, said parcel being all that real property lying north of the northerly right of way line of Holcomb Road and south of the following described line:

Beginning at a 5/8" iron rod with yellow plastic cap stamped "COMPASS ENGINEERING at the most southwesterly corner of the property described in Deed Book 633, Page 151 as per the survey recorded as SN-29771, Survey Records of Clackamas County; thence South 82°56'04" East, along the northerly right of way line of Holcomb Road as per said survey SN-29771, 43.50 feet to a point; thence along the arc of a 250.00 foot radius non-tangent curve to the right, through a central angle of 22° 00' 00", for an arc distance of 95.99 feet (the long chord of which bears North 89°35'00" East, 95.40 feet) to a point; thence South 79° 25'00" East, 26.00 feet to a point; thence North 10°35'00" East, 5.00 feet to a point; thence South 79° 25'00" East, 10.00 feet to a point; thence South 10°35'00" West, 5.00 feet to a point; thence South 79° 25'00" East, 12.07 feet to a point on the westerly line Holcomb School Road as per said survey SN-29771; thence along the arc of a 25.00 foot radius non-tangent curve to the right, through a central angle of 07° 39' 42", for an arc distance of 3.34 feet (the long chord of which bears South 49°17'21" West, 3.34 feet) to a 5/8" iron rod with yellow plastic cap stamped "COMPASS ENGINEERING at the northwesterly corner of the right of way dedication granted by document No. 2001-110308, deed records of Clackamas County, and the terminus of this line description.

EXCEPTING therefrom that portion within the right of way dedication granted by Document No. 2001-110308, deed records of Clackamas County.

Containing 1400 Sq. Ft., more or less.

The bearings for this description are based on the 5/8" iron rods with yellow plastic cap stamped "COMPASS ENGINEERING", set on August 28th, 2002 at the most southwesterly corner of the property described in Deed Book 633, Page 151 and at the intersection of the northerly right of way line of Holcomb Road and the PC of a 25.00 foot radius curve on the westerly line of Holcomb School Road.
