**CITY OF OREGON CITY, OREGON
PUBLIC UTILITY(S) EASEMENT**

KNOW ALL BY THESE PRESENTS, THAT Abernethy Center an Oregon Limited Liability Company hereinafter called the GRANTOR, do(es) hereby grant unto the City of Oregon City, hereinafter called the CITY, its successors in interest and assigns, a permanent easement and right-of-way, including the permanent right to construct, reconstruct, operate, and maintain Sidewalk on the following described land:

Exhibit "B" Sketch for Legal Description

TO HAVE AND TO HOLD, the above described easement unto the CITY, its successors in interest and assigns forever.

GRANTOR reserves the right to use the surface of the land for walkways, plantings, parking, and related uses. Such uses undertaken by the GRANTOR shall not be inconsistent or interfere with the use of the subject easement area by the CITY. No building or utility shall be placed upon, under, or within the property subject to the foregoing easement during the term thereof, however, without the written permission of the CITY.

Upon completion of the construction, the CITY shall restore the surface of the property to its original condition and shall indemnify and hold the GRANTOR harmless against any and all loss, cost, or damage arising out of the exercise of the rights granted herein.

The true consideration of this conveyance is \$3.00, the receipt of which is hereby acknowledged by GRANTOR.

And the GRANTOR above named hereby covenants to and with the CITY, and CITY's successors in interest and assigns that GRANTOR is lawfully seized in fee simple of the above granted premises, free from all encumbrances except a loan number 1262 from Town Center Bank of which the bank has no objection to this easement, and that GRANTOR and their heirs and personal representatives shall warrant and forever defend the said premises and every part thereof to the CITY, its successors in interest and assigns against the lawful claims and demands of all persons claiming by, through, or under the GRANTOR.

In construing this deed and where the context so requires, the singular includes the plural and all grammatical changes shall be implied to make the provisions hereof apply equally to corporations and to individuals.

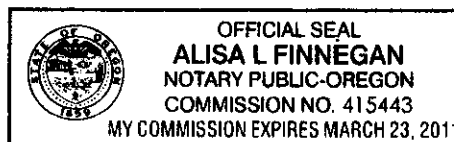

**EXHIBIT A
SIDEWALK EASEMENT**

Being a portion of Lot 8, Block 71 of the Plat of "Oregon City" as described in that Warranty Deed recorded as document number 99-016313, Clackamas County Deed Records located in the Southwest One-Quarter of Section 29, Township 2 South, Range 2 East of the Willamette Meridian, in the city of Oregon City, Clackamas County, Oregon being more particularly described as follows:

Beginning at the intersection of the southerly right of way line of 15th Street and the easterly right of way line of Washington Street being the most northerly corner of Lot 8, Block 71 of the Plat of Oregon City;

Thence S 54°27'41" E, along the southerly right of way line of said 15th Street, 9.00 feet to the beginning of a 13.34 foot radius non-tangent curve to the left having a central angle of 66°02'19", the radius point of which bears S 08°48'21" W, 13.34 feet;

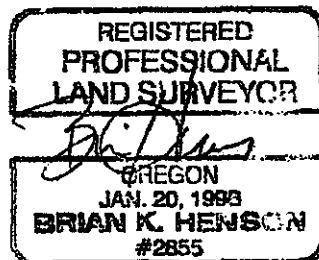
Thence along the arc of said non-tangent curve to the left (the long chord of which bears S 65°47'11" W, 14.54') 15.38 feet to a point;

Thence N 54°29'54" W, 1.67 feet to a point on the easterly right of way line of said Washington Street;

This legal description along with the basis of bearings thereof was established based on that Record of Survey recorded as survey number 2006-406. Clackamas County Survey Records.



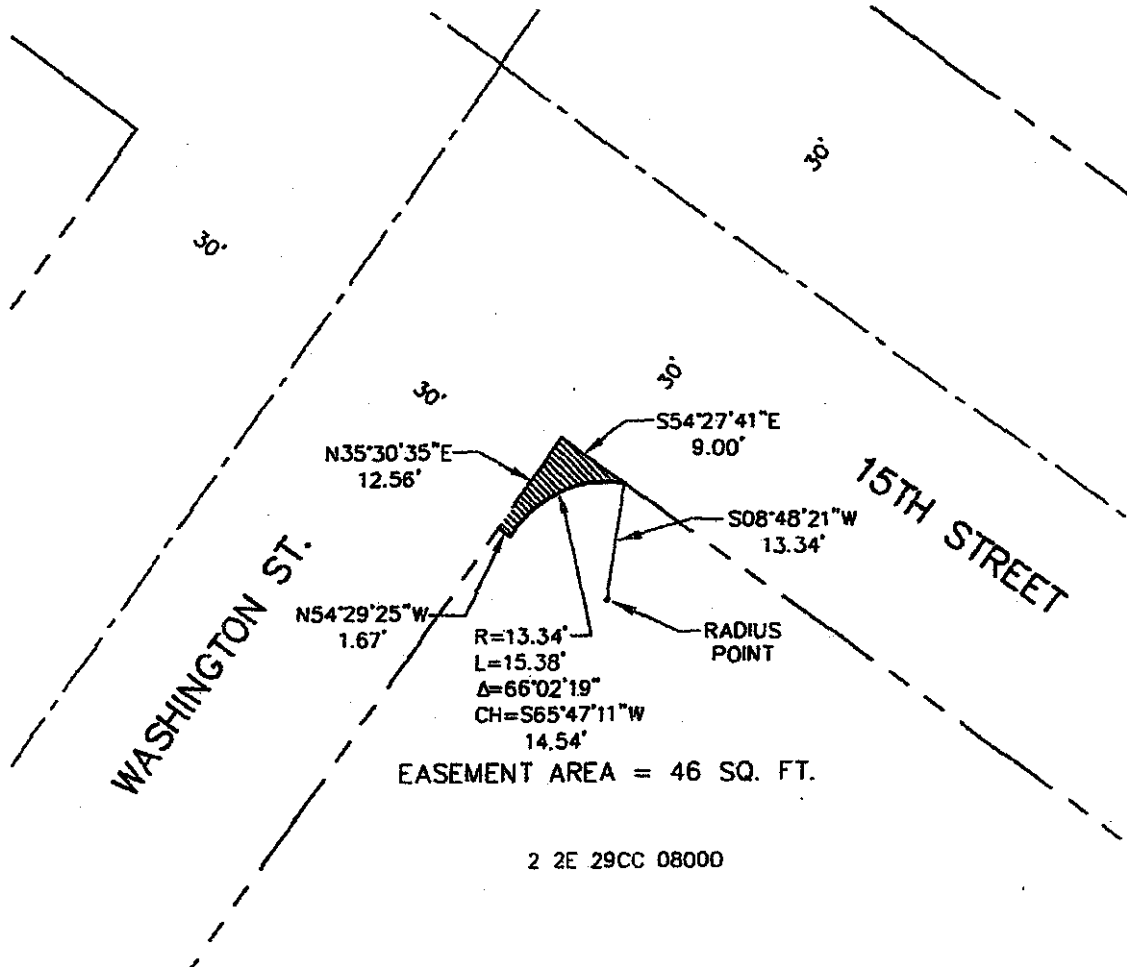
