KNOW ALL MEN BY THESE PRESENTS, That CROWN ZELLERBACH CORPORATION, a Nevada corporation, as Grantor, in consideration of the sum of Ten (\$10.00) Dollars, and other good and valuable considerations, the receipt of which is hereby acknowledged, does hereby grant and give to the CITY OF OREGON CITY, OREGON, a municipal corporation of the State of Oregon, as Grantee, its successors and assigns, a permanent easement and right of way for the construction, operation and maintenance of a sewer pipe line as now located and constructed on a strip of land ten (10) feet in width, said strip of land being five (5) feet wide on each side of the center line, which extends in a general Northerly and Southerly direction, over and upon the following described parcels of land, in Clackamas County, Oregon:

PARCEL NO. 1

The center line of the above mentioned strip of land extends across Lots 1, 2 and 3, Block 44, Oregon City, Oregon, as follows:

Beginning at a point on the Southeasterly boundary of Lot 3, Block 44, Oregon City, Oregon, which is approximately 16 feet Southwesterly from the Northeast corner of said Lot 3; thence North 5° 08' East approximately 160 feet to a point on the most Northerly boundary of Lot 1 of said Block 44, which Northerly boundary is also the Southerly boundary of the George Abernethy DLC No. 58 in Township 2 South, Range 2 East of the W.M., said point being North 82° West approximately 42 feet from the point where the most Northeasterly boundary of said Lot 1 intersects the Southerly boundary of said George Abernethy DLC, except from said strip of land that portion thereof lying within the alley between Lots 2 and 3 of said Block 44;

PARCEL NO. 2

The center line of the above mentioned strip of land continues thence across that certain tract of land containing 3 50 ceres BEER 490 TAGE 738

Beginning at a point on the Southerly boundary of the George Abernethy DLC No. 58 in Township 2 South, Range 2 East of the W.M. at a point North 82° West approximately 42 feet from the point where the Southerly boundary of said George Abernethy DLC is intersected by the most Northeasterly boundary of Lot 1, Block 44, Oregon City; thence North 5° 08' East approximately 164 feet to a point; thence North 44° East approximately 158 feet to a point on the Northeasterly boundary of the 3.50 acre tract referred to above, said point being North 59° West approximately 80 feet and North 27° 40' West approximately 145 feet from the point where the Southwesterly boundary of Block 5, Green Point Addition to Oregon City intersects the East boundary of the East Side Super-Highway;

PARCEL No. 3

The center line of the above mentioned strip of land also crosses that certain tract of land containing 12 acres situated in the Hiram Straight DLC No. 42 in Township 2 South, Range 2 East of the W.M., which tract of land is described as "Parcel A" in that certain deed from Ostrander Railway and Timber Company to the herein named Grantor dated November 28, 1945 and recorded in Volume 358, Page 61 of the Deed Records of Clackamas County, Oregon, as follows:

Beginning at a point on the West boundary of the right of way of the East Side Super-Highway which is North 3° 49' West approximately 86 feet from the Southeast corner of the 12 acre tract referred to above; thence North 7° 11' West 235.28 feet to a point; thence North 18° 23' West 220 feet, more or less, to a point on the Southerly boundary of that certain 1.65 acre tract conveyed by the herein named Grantor to the City of Oregon City, Oregon by deed dated Manuny 124/1955, 1954, and recorded in Book 490 at Page 734, Deed Records of Clackamas County, Oregon; said point being North 85° 17' West approximately 75 feet from the Southeast corner of said 1.65 acre tract.

5. Right, title and interest, if any of the City of Oregon City as disclosed by deed recorded May 3, 1946 in Book 366, page 412, Deed Records.

Reserving in perpetuity however, unto the Grantor its successors and assigns, the unrestricted right to, at any time in the future, survey, construct and maintain a road or roads over which the Grantor, its successors and assigns may travel and/or truck haul logs and other forest products and/or such equipment and material as may be necessary in the conduct of its business, such road or roads to cross the 10 foot-wide pipe line easement and right of way, granted hereunder, at such location or locations as may be deemed necessary in order to effect the most desirable alignment and gradient of such road or roads, it being further understood that the use of such road or roads may be conducted without recourse by reason of damage to such pipe line.

Provided, however, that if the Grantor shall construct a road or roads over said pipe line and remove the covering material to a¹ point less than four (4) feet above the top of the pipe, it will cover said pipe with a concrete slab or other reinforcing material of sufficient thickness to minimize possible damage to the pipe line.

TO HAVE AND TO HOLD the above described and granted right, privilege and easement unto the said Grantee, its successors and assigns, forever, subject to the aforesaid encumbrances and the aforementioned reservation.
