Subject: Replacement of Old Mountain Line

Dear Mr. and Mrs. Ewing:

The City of Oregon City is planning the construction of the above captioned project. As you are aware through our discussions, property you own will be affected by this project. A Waterline Easement will be necessary in order to give the City the legal right to complete the construction of the waterline.

In exchange for executing the documents and granting the above rights, and subject to approval, the City agrees to the following:

- 1. To compensate you, in full, for the Easement in the amount of \$100.
- 2. To clean up the construction debris at the conclusion of the project.
- 3. To replace and repair fencing with as good quality or better.
- 4. To compensate you in the amount of \$1,400.00 for the cost of restoring the lawn and shrub area and for the cost of repairing the decorative fountain which will be disturbed.
- 5. To avoid damage to the swimming pool and decorative rock retaining walls, by utilizing constructin methods which will protect the structure or to repair any retaining wall or concrete flatwork damaged by the project, and to restore any possible damage to as good or better condition.

- 6. To provide temporary fencing in the event that fencing is disturbed during construction. This fencing is intended to prevent neighborhood children from entering your yard and getting near or in the pool, and is to be in place at all times that the regular fencing is not restored.
- 7. To restore the berm at the water fountain if the fountain is taken or the berm is affected by the construction of the water line, so that you can reconstruct the fountain after the project is completed. The configuration of the berm to be similar in nature to the existing berm at the fountain.
- 8. To compensate you in the amount of \$500.00 for your cost to restore the fountain rock work and to remove all of the rock fountain as part of the construction.
- 9. To blade any affected lawn or landscaped area to a grade compatible with the application of new lawn or landscaping.
- 10. To complete the trenching work on the property within a period of ten working days from the time work commences at your property. It is understood that testing and some additional restoration work could extend past the ten days.
- 11. To provide you a one week notice prior to commencing work on the property. This will allow you to provide an alternate location for your camper and boat, which are presently located in the proposed easement area. This will also allow time to return from a short business trip in time to effect the relocation of the boat and camper.
- 12. To replace all graveled areas affected by the construction with 3/4 minus crushed rock to a thickness of 3 inches.
- 13. To abandon the unused portion of the existing Old Mountain Line Water Transmission Line easement on your property at no cost to you by quitclaiming this excess and paying recording and description costs.

The total compensation for the above is \$2,000.00. Payment will be made in approximately 30 days. Thank you for your cooperation with the City of Oregon City.
