A parcel of land 15-feet wide for a slope easement situated in the southeast quarter of Section 6, Township 3 South, Range 2 East, Willamette Meridian, Clackamas County, Oregon, described as follows:

A portion of that certain parcel of land as described in Fee Number 88-06091 recorded February 17, 1988, Clackamas County Deed Records, being 35.00 feet easterly (measured at right angles) of the line between the southwest corner of the William Holmes Donation Land Claim No. 38 and the northeast corner of the S.S. White Donation Land Claim No. 41 also being the center line of Leland Road (40-feet wide); said easement being 15.00 feet easterly of the present easterly right-of-way line.

And the GRANTOR above named hereby covenants to and with the CITY, and CITY's successors in interest and assigns that GRANTOR is lawfully seized in fee simple of the above granted premises, free from all encumbrances (no exceptions) and that GRANTOR and their heirs and personal representatives shall warrant and forever defend the said premises and every part thereof to the CITY, its successors in interest and assigns against the lawful claims and demands of all persons claiming by, through, or under the GRANTOR.
