EASEMENT

KNOW ALL MEN BY THESE PRESENTS, That HOWARD E. WHITE, hereinafter called grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto OREGON CITY, a municipal corporation of the State of Oregon, hereinafter called grantee, and unto grantee's heirs, successors and assigns, the following described real property situated in the County of Clackamas and State of Oregon, to-wit:

An easement for the installation and maintenance of underground utilities together with the right to temporarily utilize adjacent property necessary for initial construction with the surface to be restored to its comparable pre-existing condition, described as follows:

Beginning at the S.E. corner of that tract of land conveyed to Oregon City, a municipal corporation, in Book 595, page 127 of Clackamas County Deed Records. Said S.E. corner being more particularly described as follows:

Commencing at a Brass Screw located at the intersection of Oregon State Secondary Highway No. 215 (Oregon City to Molalla), and Clackamas County Market Road No. 11, and which intersection is North 89° 15' East a distance of 3693.04 feet from the N.W. corner of the Vance D.L.C. No. 51, in T. 3 S., R. 2 E., W.M., when measured along the North boundary of the said Vance Claim, and South 28° 31' East a distance of 702.65 feet measured along the center line of said State Highway 215, said Brass Screw also being the point of intersection of a 1° curve to the S.W. on said Highway 215; thence, South 30° 10' East a distance of 344.56 feet; thence, continuing South 30° 10' East a distance of 115.44 feet; thence, North 88° 53' 30" East a distance of 119.48 feet to the S.E. corner of said Oregon City tract and the TRUE POINT OF BEGINNING; thence, North 30° 10' West along the East line of Oregon City tract 11.44 feet; thence, North 88° 53' 30'' East parallel with the South line of that tract conveyed to Howard White in Fee No. 77-5018, Clackamas County Deed Records - 251.50 feet; thence, at a right angle to the preceding course, North 1° 06' 30" West 15.00 feet to the right-of-way line of Market Road No. 11 (Beaver Creek Road); thence, South 60° 56' East along said right-of-way line 49.74 feet to the intersection of said rightof-way line and the aforementioned South line of the Howard White tract; thence. South 88° 53' 30" West along said South line of the Howard White tract 288.95 feet to the True Point of Beginning.

To Have and To Hold the same unto the said grantee and grantee's heirs, successors and assigns forever.

The true and actual consideration paid for this transfer stated in terms of dollars is \$10 and other good and valuable consideration.

Grantor agrees to convey an additional easement for the same purposes at such time as the grantee in cooperation with the TRI-CITY SERVICE DISTRICT is ready to begin construction of a trunk line, which is contemplated to be within five years, said easement described as follows:
