

R E S O L U T I O N

WHEREAS, the improvement of South Eighth Avenue from the North line of Baseline Street to a point fifteen feet south of the center line of East Washington Street in Hillsboro, Oregon, which improvement was authorized by Ordinance No. 1120 of the City of Hillsboro, has been completed and the total cost thereof has been ascertained and certified by the City Engineer to the City Recorder and by him reported to the City Council and is in the sum of \$947.55; and

WHEREAS, it is necessary to apportion the amounts of the whole cost to the properties properly chargeable therewith.

NOW, THEREFORE, BE IT RESOLVED, That the Council apportion the costs and expenses of the improvement of South Eighth Avenue from the North line of Baseline Street to a point fifteen feet south of the center line of East Washington Street in Hillsboro, Oregon, as follows, to-wit:
