RESOLUTION

WHEREAS, the improvement of West Washington Street, from a point 406 feet westerly from the west line of Adams Avenue to the east line of South Dennis Avenue in the City of Hillsboro, Oregon, which improvement was authorized by Ordinance No. 1275 of the City of Hillsboro, has been completed and the total cost thereof has been ascertained and certified by the City Engineer to the City Recorder and by him reported to the City Council and is in the sum of \$6,477.95; and

WHEREAS, it is necessary to apportion the amounts of the whole cost to the properties properly chargeable therewith.

NOW, THEREFORE, BE IT RESOLVED, That the Council apportion the costs and expenses of the improvement of West Washington Street, from a point 406 feet westerly from the west line of Adams Avenue to the east line of South Dennis Avenue in the City of Hillsboro, Oregon, as follows, to-wit:

Beginning at a point on the south line of West
Washington Street, said point being 406.0 feet west
and 33.0 feet south of the intersection of the west
line of South Adams Avenue and the south line of
West Washington Street in the City of Hillsboro,
Washington County, Oregon, and running thence North
89° 24' West 141.05 feet to a point 1.4 feet west of
the northwest corner of Lot 57 as shown on an unrecorded plat of Tongue's Addition to Hillsboro;
thence South 0° 36' West 119.1 feet to a point;
thence North 0° 36' East 143.77 feet to a point;
thence North 0° 36' East 119.1 feet, more or less,
to the place of beginning.

Terminal Ice and Cold Storage Co. - - \$ 758.98

A roadway 8.0 feet in width, being the area between the rails and a distance of 18" on each side thereof with the centerline described as follows:
Beginning at a point in the centerline of West Washington Street 439 feet West of the centerline of Range Street and running thence West along the centerline of West Washington Street 673.2 feet, more or less, to a point of intersection with the east line of South Dennis Avenue in Hillsboro, Washington County, Oregon.

Oregon Electric Railway Company - - - \$ 773.74

Being a part of Section 36, TlN, R3W, W.M. and more particularly described as beginning 923.91 feet west of the intersection of the west line of North Range Street with the north line of Washington Street extended; thence North 197.59 feet; thence West 108.56 feet; thence South 197.64 feet; thence East to the place of beginning.

Clarence W. & Frances Maas - - - - 3 382.38

All of Lot or Tract known as Tract No. 67 of Tongue's Addition to Hillsboro, described as follows: Beginning at a point on the north line of Washington Street in the City of Hillsboro, County of Washington, State of Oregon, which point is also the southwest corner of the land owned by E. Beginning at the intersection of the South line of West Washington Street and the East line of South Dennis Avenue and running thence South 89° 24' East along the South line of West Washington Street 532.12 feet to a point; thence South 0° 36' West 200.0 feet to a point; thence 89° 24' West 532.12 feet to a point on the east line of South Dennis Avenue; thence North 0° 36' East along the easterly line of South Dennis Avenue 200.0 feet to the place of beginning.
