November 3, 2010

1. Convene Regular Meeting of November 3, 2010, and Roll Call

Mayor Norris called the meeting to order at 7 p.m.

Mayor Norris shared a letter from Jordan Kelp regarding her hopes for the re-opening of the End of the Oregon Trail Interpretive Center.

4. <u>Citizen Comments</u>

William Becker of Portland was a McLoughlin Memorial Association Trustee. He announced a fundraising event on Friday.

David and Marcia Skinner of Oregon City said four days after Mr. Skinner testified at the last Commission meeting, another vehicle ran into the cinder block barrier he placed there at his own expense and now there was no barrier to protect his house. He thought a barrier needed to be placed in the area. Public Works installed reflective arrows and striping and extra signage to help.

David Frasher, City Manager, said Public Works and the Police Department had reviewed the situation and it looked like the accidents were alcohol related rather than speed related. Nancy Kraushaar, City Engineer and Public Works Director, said a traffic safety engineer was going to be brought in to determine if the barrier in the public right of way was the right thing for this location. Mike Conrad, Police Chief and Public Safety Director, said there had been increased police patrol on the weekends in that area.

Tom Hosey, Building Official, said this resolution established a flat fee for the installation of solar systems primarily for residential. Staff recommended adoption of the resolution. These fees were consistent with other municipalities.

Ms. Kraushaar said ODOT had set up a grant program for funding geared towards bicycle and pedestrian transportation improvements that were non-highway improvements. She thought the Main Street Sidewalk Project would be competitive for the grant. There was a minimum 10.27% local match required.

Motion by Commissioner James Nicita, second by Commissioner Rocky Smith, Jr. to approve Resolution No. 10-29, Committing Local Political and Financial (Local Match) Support for the Downtown Oregon City Connective Corridor -Pedestrian and Bicycle Improvements-Main Street 5th to 15th Streets (Phases 1 and 2), Oregon City, Oregon, and Endorsing the Application for Oregon Department of Transportation Flexible Funds.

He reported on the first City/County interface meeting which was held yesterday. This would become a monthly meeting.

Maureen Cole, Library Director, discussed the new Library Behavior Policy.

Ms. Kraushaar gave an update on the Leland Road project which had been delayed, installing a school zone for Holcomb Elementary School, and Jughandle project tree cutting which would begin in January.

Commissioner Neeley discussed the lack of sidewalks on Leland and the suggestion to reduce the speed of traffic where there were no sidewalks.

Tony Konkol, Community Development Director, gave an update on the County's biomass energy facility proposal. The County planning staff was recommending denial.

Dan Drentlaw, Economic Development Manager, gave an update on the Oregon City Shopping Center redevelopment plan. The Center managers had no interest in tying into the Cove development.

Chief Conrad announced Sergeant Dave Canucci received the Life Saving Award from the Oregon Association of Police Officers.
