

ORDINANCE NO. 1689

AN ORDINANCE OF THE CITY OF MILWAUKIE, OREGON DETERMINING THE PRELIMINARY FINAL COSTS OF THE IMPROVEMENTS IN THE OCHOCO STORM DRAINAGE 90-1 LOCAL IMPROVEMENT DISTRICT; APPORTIONING THE COST AMONG THE BENEFITED PROPERTIES, SPREADING THE ASSESSMENT AND DIRECTING THE ENTRY OF ASSESSMENTS IN THE LIEN DOCKET AND SETTING THE INTEREST RATE.

WHEREAS the Council Finds:

1. The Ochoco Storm Drainage 90-1 Local Improvement District was formed and the improvements directed to be made by Ordinance No. 1685.
2. The improvements will be made in accordance with the plans and specifications contained within the preliminary engineering report adopted by Resolution 6-1990.
3. Individual mailed notice of the proposed assessment for each property was mailed to each property owner on August 10, 1990. The notice advised the property owner of the opportunity to object in writing to the proposed assessment and that written objections would be considered at a public hearing. The public hearing was held on August 21, 1990.
4. One property owners filed written objections. The Council considered these objections.
5. The total preliminary final cost to be assessed is the sum of \$75,897.58 and is assessed. The assessments against individual properties are as set forth in the assessment roll and each property is specifically benefited in the stated amount.

THE CITY OF MILWAUKIE DOES ORDAIN AS FOLLOWS:

Section 1: The preliminary total cost of \$75,897.58 shall be assessed against the individually benefited properties as apportioned in the assessment roll entitled Assessment Roll for Ochoco Storm Drainage 90-1 Local Improvement District and dated August 21, 1990.

Section 2: The Finance Director shall mail an Assessment Notice to each property owner and the notice shall state the amount of the assessment which is due immediately and that applications may be made to make installment payments. Such applications shall be reviewed by the Finance Director for eligibility. Interest to begin accruing October 1, 1990.

Section 3: The Finance Director is directed to enter each benefited property and the amount of the assessment against the property as shown on the Assessment Roll for Ochoco Storm Drainage 90-1 Sanitary Sewer Local Improvement District dated August 21, 1990, in the lien docket of the City separate from other prior or subsequent assessments and the same shall constitute a lien against each respective property and bear the interest rate of the net effective interest rate of the bond at the time it was sold plus a two percent charge until paid.

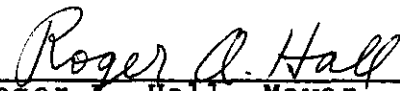

Read the first time on August 21, 1990, and moved to second reading by vote of the City Council.

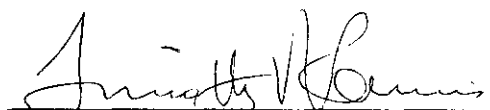
