

**RESOLUTION NO. 6-2011**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILWAUKIE, OREGON, approving the proposed transfer of Deines Brothers Sanitary Service's franchise area (Area 3) to Hoodview Disposal and Recycling; the proposed transfer of Deines Brothers Sanitary Service's 50% interest in the P. Deines franchise area (Area 4) to the owner of Mel Deines Sanitary Service; and, amending Resolution 56-2005 and the Garbage Zone map to reflect this change.**

**WHEREAS**, Deines Brothers Sanitary Service has been franchised and providing garbage and recycling services to customers in Garbage Collection Area 3 and portions of Area 4 in the City of Milwaukie for over 30 years; and

**WHEREAS**, Deines Brothers Sanitary has requested a transfer of their Area 3 franchise to Hoodview Disposal and Recycling and 50% of their interest in P. Deines to Mel Deines Sanitary Service; and

**WHEREAS**, Milwaukie City Code section 13.24.130, Transfer of Franchise, describes the requirements for transfer of franchises and Deines Brothers has met all those requirements; and

**WHEREAS**, the City's review of financial and technical documents submitted by Hoodview Disposal and Recycling and Mel Deines Sanitary Service indicates that they have the knowledge, experience and financial resources to meet all obligations of a garbage franchisee;

**NOW, THEREFORE, BE IT RESOLVED** that:

Section 1: The transfer of Solid Waste Franchise Area 3 to Hoodview Disposal and Recycling is hereby granted.

Section 2: The transfer of Deines Sanitary Services' 50% interest in P. Deines to Mel Deines Sanitary Service is hereby granted.


Section 3: The list of franchised haulers in the City of Milwaukie, adopted by Resolution 56-2005, shall be replaced with the following:

Clackamas Garbage., Inc.  
Hoodview Disposal and Recycling  
Mel Deines Sanitary Service, Inc.  
Oak Grove Disposal Co.  
Pearl Deines Disposal Co.  
Waste Management of Oregon, Inc.  
Wichita Sanitary Service

Section 3: The Map of the Solid Waste Franchise Service Areas of the City of Milwaukie, also adopted by Resolution 56-2005, shall be amended to list Hoodview Disposal and Recycling as the service provider for Area 3.

This resolution is effective on 1/18/11.


