- 1. Call to order at 7:15

- 5. Presentation- John Lewis, Public Works Director-Revocable ROW Permit Promontory Avenue

John gave summary of events leading to this Revocable ROW Permit for a single residence on Promontory and the relationship with the Trails Master Plan. Informational as it has a relationship with a noted future trail connection.

 - a. Willamette Falls Legacy Project standing update: press release from Sept 19 from Willamette Falls Communications Lead, Lisa Konkola, was provided for PRAC information. Provided Riverwalk Pre-Concept Phase Partners Group Update. WFLP would like to provide an update at the December meeting to present the alternatives and gather feedback.
 - b. Waterfront Master Plan update: Update from Sept. 15 joint Oregon State Marine Board and City Open House regarding the Clackamette Park Boat Ramp Relocation. Provided

handout of the power point presentation from the Open House. Discussion for support from City for moving forward with the concept for the new ramp location. Discussed timeline for process to complete new ramp location construction. Discussed the relationship of the new ramp and traffic pattern with the park and impacts to the park. Neeley makes a motion PRAC recommend to the City Commission to move forward with the Marine Board's recommended relocation for new Clackamette Park Boat Ramp. Motion Approved.

 11th Work Session agenda.
- f. Vietnam Memorial Wall project: Vietnam Memorial Wall proposed originally to be along the Promenade and next to the stairs across from the VFW building. Due to property ownership issues, the site proposal has moved next to the VFW building. Party with a Purpose will be launching activities for fundraising and engaging the architect for designs for new location. Looking to be on the October agenda to provide an update.

Grant Committee is meeting for a grant Sept 23 with the Clackamas County Cultural Coalition for a planting, concrete pad for a sculpture and a bench. In the future, look to place a sculpture in the future. Short discussion regarding the Charter Park project.

Doug Neeley: Attended the Pickleball group's grand opening. Passed out GOCWSC breakfast flyer fundraiser. Noted NRC heard about the OCPF removal of invasive species at Waterboard and provided a letter of support. Doug mentioned GOCWSC also supported the project.

Blane Meier: OC Trails Alliance meeting discussed tie into OC Parks Committee and OCPF, want to become experts on Trails Map and support Parks and Rec and support the Trails MP. OCTA received a grant for bike racks. Visited the Old Canemah Park, noting that the trail is very steep and would be a place to make more accessible in the future. OCTA supported the OCPF grant applications, as well.
