Presentation: Oregon City Public Works (OCPW) re: Linn Ave Concept Plan

Wallace Engineering hired to evaluate constraints and identify ways to improve sidewalk, pedestrian safety, bike lanes, sewer lines, utilities, etc.

Area runs from 5th & Jackson to Meyers & Moccasin, through 6 different Neighborhood Associations.

Currently, there is no funding for this project; the city is getting the project "shovel ready" for seeking grants.

Presentation: METRO re: Newell Creek Canyon Project.

Dave Elkin, Landscape Architect, explained the restoration activities – remove invasive plants, evict the human population and plant native species in the 330 acre site. Metro will hold an informational meeting Tuesday, April 29th 5PM at the Pioneer Community Center to solicit public comments on how people want the site to be used. A draft concept plan should be completed in October this year.

Presentation: Oregon City Backs Carnegie Library (OCBCL) Political Action Committee

Doug Neeley presented information re: May 20th election on the library bond to expand our city library. The 6 million dollar bond will provide for an additional 15,000 square feet and many other improvements.

Presentation: Chris Wadsworth reminded us of the Easter Egg hunt Saturday, April 19th at Rivercrest Park. April 26th there will be a "Shred Event", cell phone recycling and drug take-back from 9-12 at OCPD parking lot. Citizens' Academy begins in September for 9 weeks. OCPA is having monthly Loss Prevention meetings for large stores. She also explained the new Neighborhood Watch Program and distributed flyers. Reviewed and approved January and March minutes. January: William moved, Faith seconded; March: Faith moved, Steve seconded. Both passed unanimously.
