

COUNCIL RESOLUTION No. 13-2018
A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MILWAUKIE, OREGON, MAKING REAPPOINTMENTS TO CITY BOARDS, COMMITTEES, AND COMMISSIONS.

WHEREAS, Milwaukie Charter Section 26 authorizes the Mayor, with the consent of the Council, to make appointments to City boards, committees, or commissions (BCCs); and

WHEREAS, the Milwaukie Municipal Code (MMC) authorizes neighborhood district associations (NDAs) to nominate residents for certain BCCs; and

WHEREAS, BCC vacancies will exist as of April 1, 2018, due to the expiration of BCC position terms on March 31, 2018; and
