That said territory within said boundaries shall be and hereby are designated as Sewer Improvement District $# \underline{H} \underline{\rho}$.

That the City Engineer be required to furnish the Council within sixty days from this date, plans, specifications and necessary rights of way for the construction of said sewer within the area herein determined together with the estimates of the work to be done and the cost thereof.
