Planning Department

Kelly Reid gave a presentation on the proposed McLoughlin-Canemah Trail. It is complementary to the Willamette Falls Legacy Project. She said it would provide connectivity between the McLoughlin Promenade and the Metro's Canemah Bluffs area. She passed out a sketch of the preferred scenarios for the trail.

Jim Nicita commented that the City had purchased a large tract of land below South End Road and the Metro property in 2010 or so for park purposes. The idea had been to form a ring around the Canemah and connect back to the McLoughlin District. He expressed the hope that this ring concept would be incorporated into the current planning for the trail.

Karen Buehrig of the Oregon City Girl Scouts Troup 45064 gave a report on the upcoming September 10 street intersection painting event at the corner of Jefferson St. and 11<sup>th</sup>. 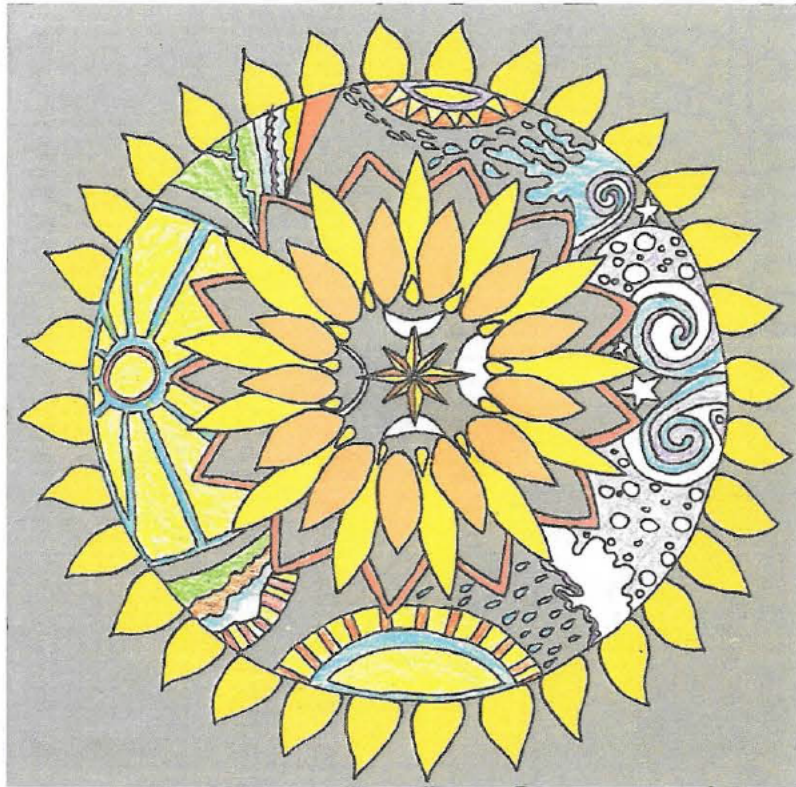
