RESOLUTION

A RESOLUTION, PURSUANT TO SECTION 33 OF ORDINANCE NO. 1699 AS AMENDED, DESIGNATING LOCATIONS OF LOADING ZONES AND THE HOURS EACH SHALL BE EFFECTIVE AND REPEALING ANY AND ALL OTHER RESOLUTIONS PERTAINING TO THIS MATTER, MORE PARTICULARLY THE CERTAIN RESOLUTION DATED OCTOBER 2, 1962, PERTAINING THERETO.

WHEREAS, Section 33 of Ordinance No. 1699, as amended provides that the City Council shall, by resolution, locate and designate loading zones, and,

WHEREAS, certain Resolutions have been enacted pertaining to this matter and all said Resolutions need be repealed for purpose of clarification.

NOW, THEREFORE, BE IT RESOLVED by the City of Hillsboro that the City of Hillsboro, Washington County, Oregon hereby designate the following described areas as loading zones with the time restrictions imposed thereon as indicated by each sign.

1. "NO PARKING LOADING ZONE". East Washington Street, North side, third space east of South 1st Avenue or 300' west of the property line at the N.W. Corner of South Second and East Washington intersection, extending westerly 20' more or less.
2. "NO PARKING-LOADING ZONE- 8 A.M.-6 P.M." East Washington Street, south side, 4th space west of South 3rd Avenue or 96.5' west of the property line at the S.W. corner of South 3rd and E. Washington intersection, extending westerly 21' more or less.
- ✓ 3. "NO PARKING LOADING ZONE". E. Washington Street, north side, 5th space west of South 3rd Avenue or 153.5' west of the property line at the N.W. corner of South 3rd and East Washington intersection, extending westerly 30' more or less.
4. "NO PARKING-LOADING ZONE." East Washington Street, north side, 4th space east of South 3rd or 131' east of the property lines at the N.E. corner of the South 3rd and East Washington intersection, extending easterly 23', more or less.
5. "NO PARKING - LOADING ZONE." South 5th Avenue, West side, 1st space south of East Washington Street or beginning at the property line of the S.W. corner of the South 5th and East Washington intersection, extending southerly 26' more or less.
6. "NO PARKING-LOADING ZONE." South 5th Avenue, west side, 4th space south of East Main St. or 80' south of the property line at the S.W. corner of the South 5th and East Main intersection, extending southerly 35' more or less.
7. "NO PARKING-LOADING ZONE." South 3rd Avenue, west side, at the 6th and 7th spaces north of East Baseline Street or from 145' south of the property line at the S.W. corner of South 3rd and East Washington intersection, extending southerly 69' more or less.
8. "LOADING ZONE-8:00 A.M. TO 10:00 A.M." North 3rd Avenue, East side 3rd and 4th spaces north of E. Main St. or 63' north of the property line at the N.E. corner of North 3rd and East Main intersection, extending northerly 48' more or less.
9. "LOADING ZONE-6 A.M. TO 12:00 NOON." North 3rd Avenue, west side, 4th space north of East Main St., or 82' north of the property line at the N.W. corner of the North 3rd and East Main intersection, extending northerly 16.5' more or less.
10. "NO PARKING-LOADING ZONE." East Lincoln Street, north side, 1st space east of N. 2nd Avenue or 16' east of the property line at the N.E. corner of the North 2nd and East Lincoln intersection, extending easterly 18' more or less.

11. "LOADING ZONE-6:00 A.M. TO 12:00 NOON." South 2nd Avenue, West side, 5th and 6th spaces south of East Main or from 136.5' south of the property line at the S.W. corner of East Main and 2nd intersection, extending southerly 49' more or less.
12. "LOADING ZONE- 6:00 A.M. to 12:00 NOON." South 2nd Avenue, east side, 6th and 7th spaces south of East Main or from 173' south of the property line at the S.E. corner of the East Main and 2nd intersection, extending southerly 47' more or less.
13. "LOADING ZONE-6:00 A.M. TO 12:00 NOON." South 3rd Avenue, west side, 4th space south of E. Main Street or from 87' south of the property line at the S.W. corner of the East Main and 3rd Avenue intersection, extending southerly 24', more or less.
14. "LOADING ZONE-6:00 A.M. TO 12:00 NOON." East Main Street, south side, 7th and 8th spaces west of 3rd Avenue or from 162' west of the property line at the S.W. corner of the East Main and 3rd Avenue intersection, extending westerly 48' more or less.
15. "LOADING ZONE-6:00 A.M. TO 12:00 NOON." East Main Street, north side, 7th and 8th spaces west of 3rd Avenue or from 148' west of the property line at the N.W. corner of the East Main and 3rd Avenue intersection, extending westerly 45.5' more or less.
16. "LOADING ZONE-6:00 A.M. TO 12:00 NOON." East Main Street, north side, 3rd space west of 4th Avenue or from 104' west of the property line at the N.W. corner of the East Main and 4th Avenue intersection, extending westerly 20' more or less.
17. "NO PARKING-LOADING ZONE." East Walnut Street, south side, 7th space west of South 10th Avenue or from 100' east of the property line at the S.E. corner of the East Walnut and South 9th Avenue intersection, extending westerly 30' more or less.
18. "NO PARKING-LOADING ZONE." East Maple Street, south side, 72' zone at the south extension of South 9th Avenue, abutting the curb on Shute Park property.
19. "NO PARKING-LOADING ZONE." North 8th Avenue, east side, 3rd space south of East Lincoln or 60' south of the property line at the S.E. corner of North 8th avenue and E. Lincoln intersection, extending southerly 60' more or less.
20. "NO PARKING-LOADING ZONE." West Main Street, south side, 4th space west of South 1st Avenue or 153.5' west of the property line at the S.W. corner of 1st Avenue and Main Street intersection, extending westerly 45.5' more or less.
21. "NO PARKING-LOADING ZONE." West Main Street, south side, 7th space west of South 1st Avenue or 249.5' west of the property line at the S.W. corner of 1st Avenue and Main Street intersection, extending westerly 72.5', more or less.

BE IT FURTHER RESOLVED that this Resolution repeals and supercedes all prior Resolutions concerning "Designating of Loading Zones," and more particularly that certain Resolution, dated October 2, 1962, pertaining thereto.

BE IT FURTHER RESOLVED that the City Engineer be and he is hereby instructed to cause to be constructed and erected appropriate signs designating the herein provided loading zones, together with the necessary painting of meter poles and other procedures in conformity with regulations in effect in the City of Hillsboro.
