On May 13, 2019 the Urban Renewal Budget Committee reviewed the proposed 2019-2021 Biennial Budget. At the meeting, the Committee approved a total budget in the amount of \$11,549,980 and requested the maximum amount of revenue that may be raised by dividing the taxes under section 1c, Article IX, of the Oregon Constitution and ORS Chapter 457.

The total budget amount of \$11,549,980 approved by the Budget Committee does not contain new projects.
