

**COUNCIL ORDINANCE No. 2191**

**AN ORDINANCE OF THE CITY OF MILWAUKIE, OREGON, AMENDING MUNICIPAL CODE CHAPTER 2.04, ADDING CITY COUNCIL COMPENSATION.**

**WHEREAS**, Chapter 3, Article 11 of the Milwaukie City Charter provides City Council with the authority to prescribe the compensation of city officers; and

**WHEREAS**, the City Council exercised that authority in 1978 when it established a monthly stipend for the positions of Mayor and City Council members; and

**WHEREAS**, the City Council increased the monthly stipend in 1989 and 2007, with the latter increase remaining as the current level of compensation; and

**WHEREAS**, the City Council wanted to create a process for determining future compensation for the Mayor and City Council members on a regular basis; and

**WHEREAS**, the City Council convened a citizen jury to consider the question of future compensation for the Mayor and City Council members; and

**WHEREAS**, the citizen jury developed a recommendation for adjusting the current compensation and regularly adjusting compensation based on the Consumer Price Index (CPI) published by United States Bureau of Labor Statistics; and

**WHEREAS**, the City Council has chosen to adopt the citizen jury’s recommendation.

**Now, Therefore, the City of Milwaukie does ordain as follows:**


Section 1. Milwaukie Municipal Code Chapter 2.04 is amended as set forth in Exhibit A.  
Section 2. The compensation set by this ordinance will be effective for the individuals elected to City Council positions 1 and 3 at the November 2020 election, with compensation at the adjusted rate to begin on January 1, 2021; and for the individuals elected to City Council positions 2 and 4 and the Mayor at the November 2022 election, with compensation at the adjusted rate to begin on January 1, 2023. Thereafter, the adjusted rate of compensation will take effect for the Mayor and City Council members with each adopted biennial budget.


Read the first time on **May 19, 2020** and moved to second reading by **5:0** vote of the City Council.

## **EXHIBIT A**

Milwaukie Municipal Code Section 2.04 is amended as follows:

Article VI. Council Compensation.

2.04.440. Compensation for the Mayor is set at \$369.00 per month and compensation for City Council members is set at \$307.00 per month. Compensation rates set by this section will be adjusted every two years during the biennial budget process and in accordance with the Consumer Price Index (CPI) published by United States Bureau of Labor Statistics.
