

COUNCIL ORDINANCE No. 2193

AN ORDINANCE OF THE CITY OF MILWAUKIE, OREGON, AMENDING THE AGENDA ORDER OF COUNCIL REGULAR SESSION MEETINGS AS OUTLINED IN MUNICIPAL CODE SECTIONS 2.04.140 AND 2.04.150.

WHEREAS, the order of City Council meeting agendas should be consistent and transparent to ensure effective and efficient transaction of the public's business; and

WHEREAS, the City Council agenda order should reflect the current needs and values of the city at present; and

WHEREAS, the City Council's regular session agenda order is set in the Milwaukie Municipal Code (MMC); and

WHEREAS, the City Council has considered several agenda order changes and has directed that the MMC be amended to adopt these changes.

Now, Therefore, the City of Milwaukie does ordain as follows:

Section 1. The agenda order and other related changes to the municipal code, as outlined in Exhibit A, are hereby adopted.

Read the first time on **June 16, 2020** and moved to second reading by **5:0** vote of the City Council.

Read the second time and adopted by the City Council on June 16, 2020.

EXHIBIT A - Council Agenda Order Code Changes (clean)

2.04.140 ORDER OF BUSINESS

- A. All regular meetings shall have the following order of business:
 - 1. Call to Order;
 - 2. Announcements;
 - 3. Proclamations and Awards;
 - 4. Special Reports;
 - 5. Community Comments;
 - 6. Consent Agenda;
 - 7. Business Items;
 - 8. Public Hearings;
 - 9. Council Reports;
 - 10. Adjournment; and
 - 11. Executive Sessions, as necessary.
- B. The order of business may be changed by the presiding officer or majority vote of the remaining Councilors.

2.04.150 DISCUSSION OF BUSINESS

A. The Council invites comments on all matters for Council consideration. Public comments on matters not on the agenda or on the consent agenda are to be presented during the community comments part of the agenda in accordance with the rules established by Council. Public hearings shall be conducted under the regulations applicable to the particular type of hearing. During the business items part of the agenda, the Council may allow statements from those wishing to speak prior to deliberation. The right to deliberate is reserved to the Council. The city manager has the right to take part in discussion but shall have no vote. The Council may invite staff and others to participate. Statements by others may be limited in duration by the Council and shall normally be limited to one (1) statement per person per agenda item.
