#### PLANNING COMMISSION SPECIAL MEETING

October 10, 1967

A Special Meeting of the Milwaukie Planning Commission was held on the 10th day of October, 1967, for the purpose of hearing business carried over from the meeting of September 19, and also for such other business as brought before the Commission. # Correspondence in Opposition:

Letter read from Mr. and Mrs. J. H. Broder, 10226 - 41st Court

Summary remarks in favor of the zone change were made by Mr. Roger Meyer, one of the applicants.

As there was no one else wishing to be heard, the hearing was declared closed at 10:00 P.M.

After a short recess the meeting was reopened and the zone change proposal came under discussion of the Commission. IT WAS MOVED by Mrs. Brod, seconded by Mr. Liddell, that the recommendation to the Council be that the application for zone change be denied.

During discussion the preponderence of neighbors in opposition was pointed out, as well as the conflict of density ratio because of the existing residences on quite large lots. It was also brought out that if so-called "buffer zones" are not limited on the side adjoining single-family residential, they have a tendency to continue to creep into the established single-family area.

Question was called for. At his request Mr. Englund was excused from voting. Ayes: Mrs. Brod, Mr. Nase, Mr. Liddell, Mr. Kennedy and Mr. Eddy. MOTION CARRIED and so ordered.

The applicants were informed that they had 10 days in which to appeal through a written request to the City Council as provided in Ordinance No. 481.

Mr. Kennedy left the meeting at 10:30 P.M.

#### SPECIAL PERMIT REQUEST:

SP-67-15 Request for a duplex at approximately 11116 S. E. Linwood.
Applicants Emmett W. and Eunice Shields.

IT WAS MOVED by Mr. Liddell, seconded by Mrs. Brod, that SP-67-15 be granted providing the applicant reposition the structure 15' southerly and 5' easterly on the lot, that a properly executed letter of intent to dedicate land 25' wide for the future street from Linwood easterly to a projection of 64th be submitted, and a letter of approval from the Clackamas County Health Department with regard to septic tank installation be submitted. THE MOTION CARRIED unanimously and so ordered.

# OTHER BUSINESS

IT WAS MOVED by Mrs. Brod, seconded by Mr. Eddy, that Bette Bierer be elected as Secretary to the Planning Commission. MOTION CARRIED and so ordered.

Max Thompson announced that Clackamas County Planning Commission would hold a meeting at 7:00 p.m. on Wednesday, October 11, in Circuit Court Room #2 in the Clackamas County Courthouse for the purpose of discussing planning work to be accomplished in the future, and read a communication inviting Milwaukie Planning Commission members to attend, or send a representative, to express their feelings about such planning in the area around their city.

Mr. Thompson also read a letter of October 4 from Clackamas County Planning Commission to Mr. Merle Manly regarding a request for an amendment to the Milwaukie-Gladstone Development Pattern for the area Tax Lot 66, Section 5, T2S, R2E, W.M. The request will be considered again at a meeting of Clackamas County Planning Commission on October 23, 1967, at 7:30 p.m. in Circuit Court Room #2 of the Clackamas County Courthouse. Any formal action to be taken by Milwaukie Planning Commission was tabled until the October 17 Regular Meeting.

Mr. Englund suggested that the Staff write a letter to the owner of the 43rd-King Apartments located at 2254 - 43rd, saying that as the property owner of the apartments he is requested to build a sight-obscuring fence along the driveway at his apartment parking area.

As there was no further business to come before the Commission, the meeting was adjourned at 11:20 P.M.
